

GLENCOE NOTES

The Library Question

An Ordinance

For the issuing of Bonds for the construction of a Septic Tank or Purification Works, an Outlet Sewer, Manholes, House Junctions, and other appurtenances belonging thereto, in the city of Highwood, County of Lake, and State of Illinois.

BE IT ORDAINED By the City Council of the City of Highwood, County of Lake, and State of Illinois:—

SECTION 1. That the Mayor and the City Clerk of the City of Highwood, in the County of Lake and State of Illinois, are hereby directed, authorized and required to issue the bond of the City of Highwood to the amount of Four Thousand Five Hundred and Forty-one dollars (\$4541.00); such bonds to be payable as follows—Forty-one Dollars (\$41.00) being payable in the year A. D. Nineteen Hundred and Six, and Five Hundred Dollars (\$500.00) annually thereafter. Such bonds shall bear interest at the rate of Five per cent (5) per annum; payable semi-annually; both principal and interest to be payable at the Bank of the Northern Trust Company in Chicago, County of Cook, and State of Illinois.

The Bond maturing in the year A. D. 1906 shall be for the sum of Forty-one dollars (\$41.00) and each of the remainder of said bonds shall be for the sum of Five Hundred Dollars (\$500.00) and all of the said bonds shall be issued and the proceeds thereof shall be used towards the construction of a Septic Tank or Purification Works, an Outlet Sewer, Manholes, House Junctions and other appurtenances thereto belonging, for the City of Highwood, in the County of Lake and State of Illinois.

SECTION 2. Said Bonds shall be signed by the Mayor of the City of Highwood and attested by the City Clerk and shall be countersigned by the City Treasurer, and shall have the Corporate Seal of said City of Highwood affixed thereto; and the bonds shall be in the same form of City Bonds issued for similar purposes, as nearly as the circumstances of the case will allow.

SECTION 3. Said bonds shall bear date October 1, 1905, and the Mayor and City Council of the City of Highwood, Lake County, Illinois, shall annually, commencing in the year Nineteen Hundred and Six (1906) provide and assess a regular annual tax, for the purpose of paying the interest on said bonds, or so many of them as shall remain unpaid at the time the annual assessment and levy shall be made; and in addition thereto the Mayor and City Council shall, in the year Nineteen Hundred and Six (1906) provide for the assessment and levy of the sum of Forty-one Dollars (\$41.00), and shall annually thereafter, commencing with the year Nineteen Hundred and Seven (1907) provide for the assessment and levy of the sum of Five Hundred Dollars (\$500.00) each year until the full amount of said bonds herein provided for has been paid; which sum or sums, when collected, shall be applied to pay the bonds falling due for the year when said tax is collected.

SECTION 4. This Ordinance shall take effect and be in force from and after its passage, approval and publication according to law.
