F. K. Bumstead, who issues the Lake county directory every two years, has furnished the press with figures, the result of his computations from the issue of 1905-6, and now in press. From Mr. Bumstead's estimates are ommitted some towns, Libertyville being one of them, he not yet having quite completed counting names and arriving at his deductions in the places not mentioned. Neither has he counted up the rural routes yet, and when his final figures are in, it will be possible to arrive at a fairly accurate estimate of the county's total population.

There are still seven towns in Lake county, exclusive of Waukegan, from which returns have not yet been made, and no return will be made from Zion City, as the authorities refused to allow Mr. Bumstead to take the names.

Only four towns have suffered a decrease, and one town-Wadsworth, gained 150 per cent, in the two years. All in all it is an exceptionally good showing for Lake county.
