Socialists Attack Primary Act

The Socialist party has attacked the new primary law in the courts and will test its validity.

A petetion for mandamus to compel the board of election commissioners of Cook county to permit the Socialists to hold a primary has been filed in the supreme court. The mandamus brings up many points in the law on which the validity will be attacked if the court takes jurisdiction.

Some time ago the election commissioners refused to permit the socialists to participate in the primary on February 24, because they had not polled at the last election at leas 20 per cent of the total vote cast in that county.

The petition which has been filed in the supreme court asks that tribunal to compel the election commissioners to permit the Socialist party to hold a primary under the old law on the ground that the new one is unconstitutional.

While admitting that the law contains some defects, the commissioners are sanguine that the court will uphold the entire act. The commissioners are prepared to defend the law.

petition are the following.

That the law is invalid because it places a financial restriction on a citizen running for public office by requiring a filing fee of from \$25 to \$100 before a candidate can have his name printed on the official primary ballot.

That the law is invalid because it requires a party to poll 20 per cent of the total vote to have a primary in Cook county and only 10 per cent in the remainder of the state.

That the law is invalid because down in the state it prevents the nomination of more than one

candidate for the legislature in one county where the district includes several counties.

That the law is invalid because the bill was not read three times in each house before it was voted upon. The critics assert that the legislature passed a conference committee report and not a bill. Legislative experts say, however, that a conference report is equivalent to a bill.

The petition has been filed by Mr. Stroever, representing the Socialists of Cook county.

"The Socialists are making the fight, but both the old parties are interested in the matter," said Mr. Strover. "No one is satisfied with the new primary law, because the more it is investigated the clearer it develops that it is not a reform measure, but a scheme to perpetuate the present political machines. There is no doubt that the law is unconstitutional, for it is a hodge-podge affair, bristling with sections that can be interpreted in a dozen different ways. It is so full of ambiguities and contradictions that one can drive a four-in-hand through it in many places.

"Inasmuch as the Socialists polled 20 per cent of the vote cast in four wards in Chicago, that party could demand a primary in these wards at least, under the law, but not in the rest of the city, and this condition adds to the general confusion arising from the numerous interpretations placed on the act."

The supreme court took jurisdiction in this case this morning when it allowed the motion for leave to file the petition. Nothing was said by the court as it entered the order taking jurisdiction. Among politicians this action of the Socialists in attacking the bill is taken seriously and it is greatly feared that the court will knock the law to pieces. It is entirely impossible to make any predictions as to the time of a decision but it is likely that, owing to the near approach of the primary day, the court will take up the subject at once and render a decision, filing the opinion later.
