## Council Meeting.

A regular meeting of the Council of the City of Highland Park was held on Tuesday evening, March 6th, 1906.

Minutes of previous meeting read and approved.

Communication from Fire Department, asking that a hose wagon be purchased for said department. Referred to Fire and Water Committee to be reported on at the next meeting.

Board of Local Improvements recommend and submit for adoption an ordinance providing for the construction of a sewer, with manholes, flushing connection and house connection slants to be laid in Lindenavenue and Linden avenue produced connecting with sewer in Maple avenue and running thence southerly along said Linden avenue to a point which would be intersected by the southerly line of lot two (?) block nineteen (12) produced easterly in its course across said Linden avenue. Carried.

Board of Local Improvements recommended and submitted for adoption an ordinance providing for construction of cast iron lateral main water supply pipe, together with fire hydrants, shut-off valves and special castings, to be laid along and under Linden avenue from Vine avenue to Maple avenue with estimate of cost-of said improvement prepared by the President of said Board and attached thereto. Carried.

## Special Assessment Notice No. 107

Notice is hereby given to all persons interested that the City Council of the City of Highland Park, County of Lake and State of Illinois, having ordered that a cast iron lateral main water supply pipe, together with fire hydrants, shut off valves and special castings be constructed, and laid along and under First street, in said City, commencing at and connecting with the water main now laid in First street, at a point in said main which would be intersected by the Northerly line of lot 16 block 6 of Fxmoor Addition to the City of Highland Park, produced Easterly in its course across said First

street (said point being the Northerly terminus of the present water main now laid in said street) and from thence said main shall run Northerly on a line parallel with and twelve (12) feet West of the center line of said First street to the South line of Burtis Avenue produced Easterly in its course across said First street, the ordinance for the same being on file in the office of the City Clerk of said tity, and having applied to the County Court of Lake County for an assessment of the costs of said improvement according to benefits, and an assessment thereof having been made and returned to said court, the final hearing thereon will be had on the 26th day of March, A. D. 1906, or soon thereafter as the business of the court will permit.

Said assessment is payable in Ten (10) installments with interest at the rate of Five (5) per centum per annum on all installments from and after date of first voucher.

All persons desiring may file objections in said court before said day, and may appear on the hearing and make their defense.
