Council Meeting

A regular meeting of the Council of the City of Highland Park was held in the Council Chamber on Tuesday evening April 3, 1605.

A petition signed by the residents and tax-payers of the City, requesting that the City Council take action to remedy the conditions existing at the viaduct on Laurel avenue at the Chicago and Northwestern Railroad.

The petition was referred to a special committee consisting of the Mayor, City Attorney and the chairman of the Street and Alley committee to confer with the proper officials of said railway company, in the matter of abating the nuisance.

A petition from the property owners on Deerfield avenue requesting that said street be improved was referred to the Board of Local Improvements recomending that they consider the improvement of asystem of streets consisting of Deerfield avenue, Hickory street, Laurel avenue, and McGovern street.

The committee on Public Building and Grounds report that they are preparing plans and specifications for remodeling the City Building. Action deferred for further consideration.

The Fire and Water Committee report the progress in the matter of the purchase of Hose Wagon for the Fire Department and ask that extension of time be granted in the matter. Granted.

The rules for the purpose of acting upon bills were suspended.

An ordinance concerning the salaries of City officers referred to the Finance Bommittee.
