we clip the following from an article prepared some years ago by Charles Richardson, for the National Municipal League. It is not only eminently true but vitally important:

"The true solution of the great problem of municipal government may be expressed in two words -Education and Organization-and the last is as essential for the first as the first is for the last.

By education in this connection is meant the development and cultivation of purer political ideals, and truer conceptions of existing conditions and of our duties and responsibilities as citizens. It must be made clear to the thoughtless and careless that the vicious and dishonest are constantly striving to secure the legislative and official positions which are intended for their own res'raint and control, and that the voter who fails to oppose them is as false to his own interests and those of his fellow citizens as if he had been a partner in a mercantile house instead of a municipal corporation, and had allowed the property of his firm to be stolen in his presence without making an effort to prevent it". P. B. P.

The Twelfth Annual meeting of the National Municipal League and the Fourteenth National Conference for Good City Government will be held at Atlantic City, N. J., on the 24, 25, 26, and 27th, of this month.

Among the questions to be discussed, and papers read on that occasion, "Ballot Reform and the Massachusetts Law" will be presented by Richard Henry Dana, Esq., of Cambridge, Mass. There has been much discussion and some sharp criticism of the Australian ballot system during the last year. The conviction is growing that the party column or the party square is harmful and tends to favor the maintenance of party lines in local affairs. This conviction was clearly in evidence at the Chicago Conference in Januarry, and at the Election Reform Conference held in New York, March 6th, under the Auspices of the National Civic Federation.
