### To Reach Milwaukee January 1st

As swiftly as 1000 graders, teamsters, foremen, cooks, repair men and laborers can rush it, the Chicago & Milwaukee Electric Railway line is being hurried on from Kenosha to Milwaukee.

Gazing upon the great belt of earth, 100 feet wide, and tediously hauled from place to place by scores of teams to make the roadbed level, one marvels that so great a task is undertaken just for the sake of reaching Milwankee. If the Greater Milwaukee advocates want to be reassured, a visit to the scene of this compiny's operations will provide them with real faith.

Millions of dollars are being put in to the task. Many tedious months the work goes on, teams and men being kept steadily at work. hour after hour, at different places along the line, so that each moment may be put to the most advantageous use, and no time or labor lost.

Out in the broiling sun, a big drove of mules plodded steadily on as a reporter was shown about the work by C. W. Merrilies, traffic manager of the Chicago & Milwaukee Elictric road. They were attached to patent dump carts, from which the bottom fell out when the driver shifted a lever at the desired spot. Now and then the waterboy would douse the animals with a bucket of cool water, and they would contentedly and lazily flick their tails in recognition, while the driver took a drink.

The spot was a mile or two north of Kenosha, where a fill of fifteen feet was being made, and the ground was brought to the spot from a tract half a mile, more or less, over which a patent loader. was moving slowly back and forth.

"We expect to be running into Racine by July 1st," said Mr. Merrilies, "and into Milwaukee by January 1st of next year. Just how soon we will get down town into Milwaukee depends to a large extent upon the litigation now involving the First Avenue viaduct, If that is adjusted so that we can go ahead, knowing where we are at, there will be no cessation of our present efforts to give Milwaukeeans the best service to be had by electric road to Chicago. The matters of time and fare are still open. We are now running cars every forty min-

utes, except on Sundays, when we run them every twenty minutes. What the new schedule will be depends upon the traffic, but I think it will be twenty minutes every day, with an increase as traffic demands."-Independent. .
