Levying Taxes for Corporate Purposes for the Fiscal Year from May 1st, 1906 to April 30th, 1907. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HIGHLAND PARK:

Section 1. That whereas the total amount of all appropriations legally made for all corporate purposes and to be collected from the tax levy of the fiscal year of said city, ending April 30th, 1907, having been ascertained by said city council to be the sum of Twenty ix Thousand Seven Hundred Twenty Six (26,726.00) Dollars and the purposes for which appropriations are made and the sum or amount appropriated for each purpose being as follows;

SEWERS

For constructing, repairing and maintaining sewers

STREET LIGHTING For stree' lighting purposes 4,000,00

PRINTING AND STATIONARY For printing and stationary purposes 190.00

For Salary of City Officers 4.804.00

SALARY OF OFFICERS

BOND AND INTEREST

For bonded indebtedness and interest 11,702.00 LIBRARY

For public 1 brary purposes 1,200.00

MISCELLANEOUS For miscellaneous corporate purposes

not hereinabove enumerated 920.00 Total \$26,726:00

Now therefore said City Council does hereby levy said Twenty Six Thousand Seven Hundred Twenty Six Dollars upon all property subject to taxation within said city as the same is assessed and equalized for State and County purposes for the current, year as the City taxes for the City of Highland Park for said year ending April 30th,

Section 2. The City Clerk is hereby directed to file a copy of this ordinance, duly certified, with the Couty Clerk of Lake County, State of Illinois, on or before September 10th, 1906
