An Ordinance

AMENDING AN ORDINANCE ENTITLED "AN ORDINANCE REVISING AND CONSOLIDATING THE GENERAL ORDINANCES OF THE CITY OF HIGHLAND PARK, COUNTY OF LAKE AND STATE OF ILLINOIS",

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HIGHLAND PARK:

SECTION 1. That Section 423 of Chapter 46, "Streets" of an ordinance of said City, entitled, "An ordinance revising and consolidating the general ordinances of the City of Highland Park, County of Lake and State of Illinois", passed April 29th, 1898, be amended to read as follows:

Before any person or persons, firm or corporation, either as principal or agent, shall make any
excavations, or openings, in any of the streets,
alleys or public places of said City, or do anything
provided for in the preceding section, such person
shall apply, in writing, to the City Clerk of said
City, for a permit in which application he shall
state the place of said proposed opening, and the
purpose of the same, which permit shall be good
for the space of thirty days from the date of its
issue, and shall provide the time in which said
work shall be completed, at the same time the person applying for such permit shall deposit with the
City Clerk the following sums:

Where said excavation, or opening, is made for the purpose of connecting any building with the public sewer, or public water main or gas main, there shall be deposited the sum of ten dollars, and where any other excavations or openings are made for any other purpose, there shall be deposited the sum of twenty five cents for each lineal foot of such excavation. Said sums of money shall be deposited to indemnify the City for the cost of expense or re-laying pavement, and material, or repairing or properly restoring any excavations, in accordance with the ordinances of the City of Highland Park, now or hereafter in force, which sums of money, or deposits said City shall have the right

to apply towards the costs and expenses of properly re-laying pavements, or restoring excavations, and furnishing material therefor, in the event that the same is not re-laid or restored, and material furnished for such relaying or restoration, to the satisfaction of the Committee on streets and alleys of the City Council of said City, or the chairman thereof, or such person as may be designated or named by such Committee or Chairman, or in the event that said work is not fully completed within the time stated in the permit, and any overplus, if any, shall be returned to the person dep siting the same, pro ided that five days written notice, signed by the City Clerk, shall first be given to the person who shall have made, authorized or permitted any such excavations, directing such person to properly re-lay the pavement, or restore such excavations, as provided by the ordinance of said City,

now or hereafter in force. Any person who, either as principal or agent, shall make any excavation or opening in the streets, alleys or public places of said city, or do anything provided for in the preceding section, without having applied for, and obtained said permit and made said deposit, as in this section required, shall be fined in the sum of not less than five dollars, (\$5.00) nor more than two hundred dollars (200.00) for each offense; and it is hereby made the duty of the City Marshal and Policemen of said City, to prevent, by force if necessary, any person from making any openings or excavations in the streets, alleys, or public places in said City, from doing any of the acts provided for in the preceding section, unless said deposit has been made, as herein required, and permit obtained, as above

SECTION 2. This ordinance shall take effect from and after its passage and publication.
