F. D. Fritsch has been on the sick list the past week, but is now out again.

The first passenger cars over the new right of way of the C. & M. E. R. R. were run today, and the old track on Waukegan avenue will soon be taken out.

The Regular Army and Navy Union elected officers last week, and chose Julius Laegeler as commander, and Mr. Hansen as adjutant. The next meeting of the Union will be held October 4th.

Mrs. John Stupey, who has been at the Augustana hospital for an operation for appendicitis and complications, is expected home tomorrow.

M. J. Gibbs has been attending the meetings of the Lake County Board of Supervisors the past few days. On Thursday the Board adjourned and went to Libertyville to inspect the poor farm, finding everything in good shape, except for some repairs to the buildings which will be made next fall.

The Annual Convention of the County Supervisors from all over the state will be held October 10 and 11 at Waukegan. M. J. Gibbs has been appointed on the transportation and theatre committee, and the program has been made up for the business and pleasure of the convention. The first day will be devoted to business, and the second day's pleasures will include visits to Ravinia Park, Fort Sheridan, Zion City, and attendance at Schwartz Theatre in the evening.

The troops of the 27th Infantry, who have been attending the manoeuvres at Fort Benjamin Harrison, Indiana, this summer, started on the march home last Sunday. It is the object of the department to make a test march under conditions such as would exist in time of actual warfare.

It is expected that four troops of the 9th Cavalry from Jefferson Barracks, St. Louis, will arrive at Fort Sheridan about October 15. The 9th Cavalry is the colored regiment which did such good work in Cuba and in China.

There will be a regular meeting of the City Council next Tuesday evening.

Charles Lehmkuhl this week announced his candidacy for the office of mayor of Highwood.

A number of sanitary improvements in the city hall have been made this week.

J. D. Martin of Libertyville has purchased the saloon property and fixtures of W. E. Felvey. It is rumored that Mr. Felvey has accepted the position of manager of a hotel at French Lick, Indiana.

Arthur O'Neil, who gave his address as Chicago was arrested for drunkenness this week and was fined \$10; after which he departed the town.

A couple from the Post presented themselves before Judge Pease this week to be married, but the Judge held up the papers for 20 days, until the groom would be discharged from the Army, it being a rule in the army that a soldier cannot be married without the Commandant's permission.

The continued assault and battery case of McNabb vs McLeren will come up before Judge Pease next Wednesday. At the same time the cases of
