High School Notes

The University of Chicago has offered scholarships in that institution for the scholars passing
the highest in examinations in English, Latin and
Mathematics, to be held at the University on Friday afternoon, November 16th. Our high school
has a representative in the English examinations,
but has none in the Latin because the subjects
called for have not been covered. There is also a
scholarship for public speaking and the contest
will be held on the evening of that day. Each
school is permitted to send two representatives, a
girl and a boy. Deerfield's representatives in this
are Gertrude Nevins and Francis Fitt.

A number of the scholars are preparing for the preliminary debate with Waukegan. The question is "Resolved That Cuba should be annexed to the United States." The affirmative will be represented by Gertrude Nevins, Frances Kemp. Kenneth King, Riley Procter and George Phillips, while Joy Miller, Carl Rommel, Madalene Rider, Letitia Jones and Francis Fitt will up-hold the negative.

On Tuesday afternoon, football practice for the school team was begun and twelve or fifteen men reported. The chances are bright for a winning team this year as the men are fast and confident and all enthusiastic about the game. The captain is James Hickey and the manager is Eddie Conrad.

Practice for the girls basket-ball team was started this week. Miss Gertrude Schaefer will coach the team. Madalene Ryder was elected captain and Gertrude Nevins manager.

On Monday morning, Mr. Edwin O. Grover gave a very interesting and instructive talk, which was much appreciated by the students. Several prominent men in this vicinity have promised to address the school, one each week. Next Monday morning Prof. Stuart of Lake Forest College will speak.

The silver cup, known as the Deerfield Cup, given by Mr. A. R. Williams, has arrived and has been on exhibition at the school. It is well worth winning.

Upwards or Downards---Which?

In all God's animated universe, there is no such thing as standing still. If you do not learn something new to-day, you will know less than you did last night, for you will almost certainly have forgotten something. If you do not gain something in physical progress to-day you will have lost something. If you are not drawn spiritually into closer communion with your Father to-day than you were yesterday, you will have receded from him. To earn an additional dollar to-day over and above your expenses is to be a dollar richer than you were yesterday, to have lost a dollar is to be a dollar poorer than yesterday; but to have done neither one you pay to be just where you were. Not by any means, neither physically, mentally nor spiritually. You may as well row out into the middle of Niagara River a hundred feet above the Falls, throw your oars into the rapids, fold your arms and expect to remain just where you are. Some years ago when one of the Pacific Railroads was being built, some workmen had gone way up the slope ten or fifteen miles beyond the last station and had left the engine standing on the track while they were working just beyond; some little jar suddenly started the engine in motion. It had gone two or three hundred feet before it was noticed. Two or three workmen started in pursuit, but before they could quite reach it, it had so increased its speed by the momentum of a down grade that it began rapidly to increase the distance between it and the workmen. A message was quickly dispatched to several stations. Before the lightning wire could take the message to the first station that an engine was loose, it was already to near for anything to be done. But at the next station, all hands were quickly summoned and a lot of sleepers or ties were quickly piled on the track The engine struck the pile, hurled them hither and thither in every direction, jumped the track and wrecked itself in a sand bank. It had run 27 miles in 20 minutes, but when it was first seen in motion the men actually gained on it.

You think one day is nothing, but every day lost is an increased momentum down grade. When that engine had gone but 50 feet a single man might have stopped it. When it had gone a mile a thousand men could not have held it. Every day lost makes it more and more impossible ever to regain one's former position.
