Ravinia Theatre

Northern Italy will be the subject of Dwight Elmendorf's journey-talk this week at Ravinia Theatre. He has divided Italy into two parts, finding it impossible to condense ten years of travel through this most beautiful of countries into a two-hour talk.

The journey from picturesque Genoa to Pisa is full of beauty and Mr. Elmendorf, avoiding the beaten tracks, shows it from an artists point of view. At Milan he uses his famous tele-photo lens to bring closer the great beauty in detail of the superb cathedral.

Florence is the next stage in the journey and it is the shrine of all art lovers. Mr. Elmendorf takes his fellow-travelers into the splendid galleries and his reproductions of Italian "Old Masters" are among the most beautiful in his collection.

Venice is the last stage of the Italian journey and it is this Queen City claims the most time, and with the aid of motion pictures we glide through the narrow canals, past the palaces and churches, the relics of past glory, until we reach the Grand Canal and join the revellers in the greatest of all Italian fetes—the Carnival of Venice.

Mr. Elmendorf will show "Northern Italy" on Saturday evening, October 27th. The last lecture of the course will be delivered next Saturday evening.

The electric cars of the C. & M. E. are running the same special schedule on days of the lectures that was in progress during the regular summer season.

In connection with the Elmendorf lectures beginning at Ravinia theatre Oct 6th, it is announced that Mr. Lester Price, general manager of the North Shore Gas Company, is to again preside at the organ, giving as last year a short popular recital before each performance.

Following the Elmendorf lectures at Ravinia Theatre the Theodore Thomas Orchestra will begin their course of winter concerts.

The first of the six concerts will be given Wednesday, November 6th. The balance of the course will be rendered on the following dates: December 14th, January 1st, January 29th, March 12th and April 9th.

[From an Educational Report of the Honorable Horace Mann just sixty years ago.]

"If we consider the earth and the fulness thereof as one great habitation or domain, then each generation, subject to certain modifications for the encouragement of industry and frugality,—which modification it is not necessary here to mention,—has only a life lease in them. There are certain reasonable regulations, indeed, in regard to the outgoing and incoming tenants—regulations which allow to the outgoing generations a brief control over their property after they are called upon to leave it, and which also allow the incoming generations to anticipate a little their full right of possession. But, subject to these regulations, nature ordains a perpetual entail and transfer from one generation to another of all property in the great substantive, enduring elements of wealth,—in the soil, in metals and minerals, in precious stones and in more precious coal, and iron, and granite, in the waters and winds and sun; and no one man, nor any generation of men, has any such title to or ownership in these ingredients and substantial of all wealth that his right is evaded when a portion of them is taken for the benefit of posterity."

If the above sentiments are sound and true, then they ought to be carried out in both state and national administration to the fullest extent possible in keeping with law and justice. If they are false, incorrect or unwise then will some one tell us why they are.
