DAMROSCH'S VIEWS

Great Conductor Gives His Ideas About Musical

It is the solem duty of the American father and mother, particularly the mother, to see that sons are given a good musical education, declared Walter Damrosch in a recent interview. The famious leader who with the New York Orchestra spent six weeks at Ravinia Park last summer and is to render a special concert at Ravinia Theatre Sunday evening, January 6th, is the most outspoken in his views on the subject.

"I cannot say too emphatically," he continued, "that musical progress in the United States depends upon our educating a large number of menin music. Music is with us too much a feminine accomplishment. We must have more male musicians. It is essential to our artistic development. Hammer that into the minds of Americans.

"It is a great mistake to suppose that the musical temperament is necessarily effeminate. The musical temperament must include the emotional susceptibility that is possessed by the female, but it also requires equally for its proper balance and perfection the intellectual vertility of the male. Strong musicians of the first rank cannot be had without both qualities. Music is with us too much left to the woman. We must take a broader view of culture and realize that a musical education is essential to every man as well as every woman of culture and well rounded personality."
