

## Notice of Retirement of Special Assessment Bonds of the City of Highland Park

NOTICE IS HEREBY GIVEN, That the undersigned City Treasurer of the city of Highland Park, Lake County, Illinois, pursuant to the provisions of Section 43 of an act of the Legislature of the State of Illinois, entitled, "An Act Concerning Local Improvements," approved June 14th, 1897, in force July 1st, 1897, has ascertained the amount of the assessments now collected, and applicable to the payment of unmatured special assessment bonds of said City, and has selected by lot, bonds hereinafter specified, to be paid therewith, as follows, to-wit:

1. Bond number 237, series "F" in the sum of \$500.00 dated June 5, 1901, bond number 238, series "F" in the sum of \$500.00, dated June 5, 1901, bond number 239, series "F" in the sum of \$500.00, dated June 5, 1901, bond number 240, series "F" in the sum of \$500.00, dated June 5, 1901, bond number 251, series "F" in the sum of \$300.00, dated July 1, 1901, bond number 252, series "G" in the sum of \$200.00, dated July 1, 1901, bond number 253, series "H" in the sum of \$200.00, dated July 1, 1901, said bonds being issued for the assessment for the following improvement, to-wit: For grading, draining, macadamizing and otherwise improving Sheridan Road (formerly known as Port Clinton Avenue) from the Northerly line of Central Avenue to the North line of Broadway Avenue (except bridges) in the City of Highland Park, County of Lake and State of Illinois.

ment for the following improvement, to-wit: For grading, draining, paving with macadam and otherwise improving Park Avenue, in the City of Highland Park, County of Lake and State of Illinois, from the Easterly line of St. Johns Avenue thence Easterly to the intersection of said Park Avenue with the Westerly line of Ravine Place, produced in its course across said Avenue.

Bond number 435, series "B" in the sum of \$500.00, dated December 10, 1903, bond number 436, series "H" in the sum of \$500.00, dated December 10, 1903, bond number 495, series "B" in the sum of \$400.00 dated June 15, 1904 and bond number 496, series "C" in the sum of \$200.00 dated June 15, 1904, said bonds being issued for the assessment for the following improvement, to-wit: For the grading, draining, paving with macadam and otherwise improving First Street, Oak and Oakwood Avenues, in the City of Highland Park, commencing at the Southerly line of Elm Place, thence Southerly along said First Street across Walnut Avenue to Oak Avenue, thence Southerly on Oak Avenue to Oakwood Avenue, thence Southerly on Oakwood Avenue to its junction with the Easterly line of Green Street, otherwise known as Green Bay Road.

ber 484, series "D" in the sum of \$100.00, dated June 8, 1904 and bond number 485, series "E" in the sum of \$300.00, dated June 8, 1904, said bonds being issued for the assessment for the following improvement, to-wit: For the construction of a connected system of sewers with manholes, flush tank and house connection slants in parts of Deerfield Avenue, Hickory Street, Laurel Avenue and McGovern Street, in the City of Highland Park, County of Lake and State of Illinois.

Bond number 684, series "B" in the sum of \$400.00, dated November 1, 1904, bond number 685, series "C" in the sum of \$400.00, dated November 1, 1904, and bond number 712, series "D" in the sum of \$100.00 dated November 21, 1904, said bonds being issued for the assessment for the following improvement, to-wit: For constructing a connected system of sewers with manholes, flush tanks and house connection on slants in the ravine crossing blocks 33, 34 and 35, also in the alley in Block 35, also in Vine Avenue, St. Johns Avenue, St. Johns Place and Maple Avenue.

Bonds number 639 and 707 respectively, series "C" each of said bonds being for the sum of \$500.00, dated respectively October 20, 1904 and November 21, 1904, said bonds being issued for the assessment for the following improvement, to-wit: For grading, draining, paving with macadam and otherwise improving a system of streets, in the City of Highland Park, County of Lake and State of Illinois, consisting of parts of Walnut Avenue, Second Street, Laurel Avenue and Elm Place.

12. Bonds number 764, 765, 766 and 767 respectively, series "B" each of said bonds being for the sum of \$500.00 and dated June 28, 1905, said bonds being issued for the assessment for the following improvement to-wit: For grading, draining, paving with macadam and otherwise improving Green Bay Road, from the south corporate limits of the City of Highland Park, thence northerly along said Green Bay Road to its junction with First Street, and First Street from its junction with said Green Bay Road, thence northerly to the north corporate limits of the City of Highland Park.

NOTICE IS FURTHER GIVEN, That said bonds above enumerated will be paid at the Bank of D. M. Erskine & Co., in the City of Highland Park, located at the northeast corner of Central Avenue and St. Johns Avenue, on the 10th day of February, 1907, between the hours of 10 o'clock in the forenoon and 5 o'clock in the afternoon.
