Public notice is hereby given that in pursuance of the statutes of the State of Illinois, in such case made and provided, award of contract has been made to Frank Laing for the making of the following described public improvement to-wit:—For the construction of a Four (4) inch cast iron water supply pipe in Central Avenue from and connecting with the water supply pipe now laid in Prairie Avenue at a point eight (8) feet west of the center line of Central Avenue, thence running South to a point Three hundred and ninety-six (396) feet South of the South line of Prairie Avenue together with (1) fire hydrant and 1 gates valve and laid in a trench with 5 1-2 feet cover above the top of the pipe, for the sum of \$425.75.

An Ordinance Providing for the Issuing of Bonds, The Proceeds Thereof to be used for the Benefit of the Public Library of the City of Highland Park.

BE IT ORDAINED by the City Council of the City of Highland Park, County of Lake, and State of Illinois:

SECTION 1. That bonds of the said City of Highland Park, to the amount of fifteen hundred dollars (\$1500.00) be issued as follows: Five Hundred Dollars (\$500.00) due July 15th, 1908, Five Hundred Dollars (\$500.00) due July 15th, 1909, and Five Hundred Dollars (\$500.00) due July 15th, 1910. Said bonds shall bear interest at the rate of five per cent per annum, payable semi-annually, both principal and interest to be payable at the First National Bank, Chicago, Cook County, in the State of Illinois.

SECTION 2. Each bond shall be for the sum of not less than One Hundred Dollars (\$100.00) and not more than Five Hundred Dollars (\$500.00), the amount to be determined by the Finance Committee of the City Council of said city, and by the Board of Directors of the Public Library of the City of Highland Park; and said bonds shall be issued, and the proceeds thereof shall be used towards the cost and construction of the Public Library Building in the City of Highland Park.

SECTION 3. Said bonds shall be signed by the Mayor and City Clerk, and shall also be signed by the President and Secretary of the Board of Directors of the Public Library of the City of Highland Park, and shall be countersigned by the City Treasurer, and shall have the corporate seal of said city affixed thereto, and said bonds shall be in the usual form of city bonds, issued for similar purposes, and as nearly as the circumstances of the case will allow, and there shall be attached to each of said bonds interest coupons evidencing the semi annual interest to be paid upon the same. Said bonds shall bear date January 15th, 1907, and the City Council of said city shall annually, commencing in the year A. D. 1907, provide, assess and levy a regular, annual tax for the purpose of paying the interest on said bonds, or so many of them as shall remain unpaid at the time the annual appropriation shall be made, and in addition thereto the council shall, in the years 1907, 1908 and 1909 respectively, provide for the assessment, appropriation, and levy of the sum of Five Hundred Dollars (\$500.00) for each of said years, which sums, when collected, shall be applied to pay the bonds falling due for the year when said tax is collected. The levy for all of said taxes shall be included in, and form a part of the levy for public library purposes for said years, and shall be subject to the restrictions provided by law with reference to the assessment and levy of taxes for public library purposes.

SECTION 5. This ordinance shall take effect and be in force, from and after its passage, approval and publication.
