Public notice is hereby given that the Board of Local Improvements of the City of Highland Park, County of Lake and State of Illinois, has filed in the County Court of Lake County, Illinois, a certificate that the following improvement has been completed, and that it conforms substantially to the requirements of the original ordinance for the construction of the same, to-wit: For constructing a connected system of sewers in the City of Highland Park, County of Lake and State of Illinois, with manholes, flush tanks and house connection slants as follows: Commencing in the bottom of the ravine which runs through Blocks 45, 46 and 47, and between 48 on the north and Blocks 31 and 33 on the south and commencing and connecting with the manhole now located in the public sewer in the bottom of said ravine at a point where said Blocks 31, 33 and 48 join or touch each other, thence westerly through said ravine to St. Johns Avenue, thence southerly along St. Johns Avenue to High Street now known as Moraine Road, thence westerly on said High Street to a point 25 feet easterly from the easterly line of Waukegan Avenue.
