### Of Interest to Highwood

The house license committee reports bill to prohibit saloons near Fort Sheridan. A report from Springfield says:

"With only nine members of the house license committee present the bill putting the Highwood saloons out of business was reported out favorably, and now will come before the house for action. It also affords the protection which Secretary Metcalf wants for the naval training school to be located near North Chicago.

"Delegation of saloon men from the Higwood resorts were in Springfield and the men who have been opposing them looked for a fight in committee.

"If it was the intention of the opponents to prevent action by breaking a quorum they were unsuccessful. Chairman Brady proceeded to put the measure to vote, and it came out without opposition,"

The Waukegan Gazette says, in part: "Simultaneously with reports from Springfield to the effect that the terrific pressure that has been brought to bear upon the State Legislature, will result in that bedy taking some favorable action upon the bill that has sent up such a wail of protest from North Shore saloon-keepers (restricting saloons about government reservations), comes the startling report that in the instance of the Bill's passage, the saloon-keepers of Highwood will move their places of business, west from their present location, so that they will be just outside of the deadline that has been drawn by the government."

The Accountants of Illinois met on Wednesday evening at the Chicago Athletic Club to organize a society. Messrs. Beach, Thorn, Hall and Griffith from Detroit, Mich., who are officers of the International Association of Accountants, were present to aid the society in its inception.
