##### Fine Home Partially Destroyed

At 10:35 a. m. Wednesday the fire alarm startled the people of Highland Park and in a few minutes the streets were alive with keen interest and the fire brigade was in full force. It transpired that the house of Mr. Frank R. Partridge, 340 Prospect avenue, was on fire.

It seems that an hour before this the two servants were aware of some smell of smoke and in a very short time discovered that it was making its way from the basement up by the register in a corner of the parlor.

On searching below they discovered fire which almost immediately burst into a great blaze in close contact with a pile of kindling wood.

After giving alarm they busied themselves in assisting to remove valuables. By the time the firemen arrived the fire had made progress and in spite of their splendid efforts it reached up along the line of plumbing to the servants' bedrooms and the garret—thence to the roof.

The fireman worked bravely and saved the main portion of the house, although the furniture suffered and the south wing will have to be partially rebuilt.

The loss is about \$6,000 or \$7,000 partially covered by insurance. The family are taken care of temporarily at the home of Mr. W. J. Fyffe.
