"THEREFORE, we learn with much satisfaction of the work of the National Vigilance Committee and urge that the promoters of this meeting, together with the joint Minister's Committee, proceed immediately to complete the organization of an Illinois State Vigilance Committee in cooperation with the National.

"And that we commend the movement to the support of all citizens as one which calls loudly for strong effort and liberal funds in order to cope with those organized iniquities."
