The winter term will be spent at Highland Park emphasizing more particularly the military feature of the school.

The Academy has always been most favorably known not only as

young men to be strong of character and gentlemanly in hearing and good citizens in truest sense.

Any citizen of our city will agree with us that the young men though seen upon our streets daily, are always found not only quiet and orderly but showing in all their actions and words the true spirit of gentlemen, and as much as we appreciate what this change of location fall and spring, will mean to the cadets in the school, we cannot but feel that it will be a real loss to the community.

The student holding the diploma of this institution will have covered work on not only rules of navigation, taking of bearings and soundings, laws of storms and how to avoid them, the use of sextant and chronometer, the determining of lattitude and longitude, and in other words, it is expected he will be able to pass a United States examination as a master of a sea-going vessel, and should be able to take a boat anywhere.
