The following was taken from the Chicago Daily Journal, March 23rd.-Highland Park's rapid growth has necessitated the building of an extension to the home of the Highland Park club. A large assembly room will be added to the bullding, which was completed in 1892 at a cost of \$19,000. The members have subscribed \$5,200 to the expense, and about \$4,000 more will be required. This will be covered by a bond issue unless additional subscriptions are made.

Attractive music and dramatic entertainments, in addition to bridge whist, cotillons, and stags, made the club extremely popular with the North Shore colony during the winter, when the necessity for an enlarged dancing floor became apparent.

Frank R. McMullin, president of the club, prepared a reorganization plan in order to raise funds which met with the approval of the charter members, who relinquished their certificates to the club, expunging all claims against the organization. Building operations will begin in lune.
