Special Assessment Notice

No. 155

Notice is hereby given to all persons interested that the City Council of the City of Highland Park, County of Lake and State of Illinois, having ordered that a local improvement be made in said city, the nature, character and locality of which improvement is as follows:

That a main sewer constructed of 12 inch diameter cast iron pipe and 12 and 10 inch diameter tile pipe, be furnished and laid in and along the bottom of the main ravine in the southern part of said City, extending west in a general direction from its outlet into Lake Michigan and lying south of and parallel with Cedar Avenue. Said sewer shall run westerly from said outlet to and across Lot 1 Block 87 in the City of Highland Park to Cedar Avenue, thence across Cedar Avenue and along that portion of St. Johns Avenue lying west of Lots 1, 2, 3 and 4 in Block 79 and Lots 1, 2, 3, 4 and 5 in Block 78 in said City of Highland Park.

That a 10 inch tile sewer shall be furnished and laid in and along the bottom of the branch of the above described ravine which extends in a northerly direction through Blocks 86 and 80 of Highland Park to Beech Street, thence westerly along Beech Street to Wade Street, thence northwesterly along Wade Street to St. Johns Avenue.

That a 10 inch tile sewer shall be furnished and laid in and along the bottom of the branch of the above main ravine which extends in a southwesterly direction between Marshman Street and Dean Avenue, said sewer shall run southwesterly to Judson Avenue.

That a main sewer constructed of 12 and 10 inch diameter cast iron pipe and 10 inch diameter tile pipe shall be furnished and laid in and along the bottom of the ravine, which, leaving the above described main ravine at its outlet, extends in a southerly direction east of Sheridan Road, and crossing Roger Williams Avenue, turns and runs in a general direction west, south of Roger Williams Avenue, said sewer shall run westerly to the east line of Lot 180 South Highland Addition to Highland Park. The said sewer shall for convenience be called the south main sewer.

That an 8 inch tile sewer shall be furnished and laid from and connecting with the west end of the said south main sewer, north along the east line of Lot 180 of said South Highland Addition and along the center line of Kincaid Street to a point where the center line of Judson Avenue, if extended, would intersect the center line of Kincaid Street, and from this point two sewers shall be constructed, one shall be laid north along the center line of Kincaid Street to within fifty feet of the south line of Roger Williams Avenue, and the other shall be laid northerly along the center line of Judson Avenue a distance of 350 feet.

That a 6 inch tile sewer shall be furnished and laid along the center line of Rice Street, from a connection with the south main sewer, north to within 100 feet of the south line of Roger Williams Avenue.

That a 6 inch tile sewer shall be furnished and laid from and connecting with the south main sewer at the point where it crosses the division line between Lots 90 and 93 of South Highland Addition, in a westerly direction along the division line between said lots and the extension thereof, to a point in Sheridan Road, from which point two branches shall be connected, one of which shall be laid north along Sheridan Road for a distance of 415 feet, and the other south to the center line of Roger Williams Avenue for a distance of 670 feet.

That a sewer shall be furnished and laid in and along the branch ravine extending southerly between Lots 63 and 66 and between Lots 76 and 77 of said South Highland Addition, which sewer shall run to the center line of Rice Street, from which point two branch sewers shall connect, one shall be laid north along the center line of Rice Street a distance of 300 feet, and the other shall be laid south along the center line of Rice Street to the center line of Roger Williams Avenue, thence west along the center line of Roger Williams Avenue a distance of 650 feet. Said sewer shall be constructed of 8 inch cast iron pipe to the center line of Cary Avenue from which point it shall be constructed of 6 inch tile.

That an 8 inch tile sewer shall be furnished and laid in Cary Avenue from a connection with the sewer in the ravine east of Rice Street west along the center of Cary Avenue and its extension to its intersection with the center line of Kincaid Street, thence south along the center line of Kincaid Street a distance of 650 feet.

That a 6 inch tile sewer shall be furnished and laid in Cary Avenue from a connection with the sewer in the ravine east of Rice Street, east along the center line of Cary Avenue a distance of 550 feet.

That a 6 inch tile sewer shall be furnished and laid along the division line between Lots 61 and 63 of said South Highland Addition from a connection with the main sewer at a point where said division line, if extended, would intersect

said main sewer, thence southwesterly to the northeast corner of Lot 62 of said South Highland Addition.

That an 8 inch tile sewer shall be furnished and laid from a connection with the main sewer at a point 2173 feet from the settling tank, measured along the line of the sewer and running thence rortherly to a point in the center line of

Dean Avenue, thence northerly along Dean Avenue and Sheridan Road to within 150 ft. of the southerly line of Beech St.

That an 8 inch tile sewer shall be furnished and laid in Cedar Avenue, from a connection with the sewer to be laid in Dean Avenue and Sheridan Road where the same crosses the center line of Cedar Avenue, thence west along the center line of Cedar Avenue to a point where the center line of Lincoln Avenue, if extended, would cross the center line of Cedar Avenue, thence northerly along the center line of Lincoln Avenue to within 150 ft. of the southerly line of Beech Street.

That a 6 inch tile sewer shall be furnished and laid in Cedar Avenue from a connection with the sewer to be laid in Cedar Avenue, at the center of Lincoln Avenue, and be laid west along the center line of Cedar Avenue a distance of 400 feet.

That an 8 inch tile sewer shall be furnished and laid in St. Johns Avenue, from a connection with the sewer provided to be laid in Wade Street, and be laid northerly along the center line of St. Johns Avenue to within 150 feet of the south line of Lincoln Avenue.

That a 6 inch tile sewer shall be furnished and laid in Forest Avenue and St. Johns Avenue, from a connection

with the sewer to be laid in Wade Street, at a point where the center line of Forest Avenue, if extended, would intersect said sewer, and be laid south along the center line of Forest Avenue a distance of 300 feet.

That a 6 inch tile sewer be laid in Beech Street from a connection with the sewer at Wade Street west along the center line of Beech Street a distance of 450 feet.

That a 6 inch tile sewer be laid in Railway Avenue from a connection with the sewer at the center line of Cedar

Avenue north along Railway Avenue a distance of 850 feet.

That an 8 inch tile sewer shall be laid in the ravine between Lots 27, 28 and 29 through Lots 141, 142, 145 and 146 of South Highland Addition, starting from a connection with the branch sewer in the ravine 1018 feet from its junction with the main sewer, thence along said ravine to Judson Avenue, thence along the center line of Judson Avenue to the center line of Roger Williams Avenue, thence west along the center line of Roger Williams Avenue to Railway Avenue, thence a 6 inch tile sewer shall run southerly along Railway Avenue a distance of 900 feet.

That a 6 inch tile sewer be laid along the center line of Roger Williams Avenue from a connection with the sewer at the center of Judson Avenue east a distance of 350 feet.

That a 6 inch tile sewer be laid along the center line of Judson Avenue from a connection with a sewer at the center line of Roger Williams Avenue southerly a distance of 320 feet.

That an 8 inch tile sewer be laid along the center line of Judson Avenue from a connection with the sewer in the ravine extending between Lots 27 and 31 of South Highland Addition, north to a point 500 feet north of the center line of Marshman Street.

That a 6 inch tile sewer be laid through Lots 150, 152, 153 and 156 of South Highland Addition, from a connection with the sewer in Judson Avenue westerly on the southerly line of Lot 150 to the southwest corner thereof, at which point two branches shall join, one running northerly along the westerly line of said lot a distance of 110 feet, and the other southerly along the westerly lines of Lots 154 and 155 a distance of 160 feet.

That a sewerage purification works be constructed with which the above described main sewers shall be connected, it shall be located in the bottom of the main ravine upon Lot 69 of the aforesaid South Highland Addition. It shall consist of a settling tank, two fitter beds, a sedimentation basin and an 18 inch main outlet sewer to Lake Michigan.

The ordinance for the same being on file in the office of the City Clerk of said city, and having applied to the County Court of Lake County for an assessment of the costs of said improvement according to benefits, and an assessment thereof having been made and returned to said court, the final hearing thereon will be had on the 5th day of April, A. D. 1909, or as soon thereafter as the business of the court will permit.

Said assessment is payable in ten (10) installments with interest at the rate of five (5) per centum per annum, on all installments from and after date of first voucher.

All persons desiring may file objections in said court before said day, and may appear on the hearing and make their defense.
