SPECIAL ASSESSMENT NOTICE
NO. 152

Notice is hereby given to all persons interested that the Council of the City of Highland Park, County of Lake and State of Illinois, having ordered that a sewer be constructed in Skokie Avenue said City, commencing at a point eighty-three feet east of the west corporate limits of the City of Highland Park, thence east along the center line of said Skokie Avenue, and said center line extended east, to and connecting with the public sewer in Green Bay Road (formerly known as First Street) the ordinance for the same being on file in the office of City Clerk of said City, and having applied to the County Court of Lake County for an assessment of the costs of said improvement according to benefits, and an assessment therefore having been made and returned to said court, the final hearing thereon will be had on the third day of May, A. D. 1909, or as soon thereafter as the business of the court will permit.

Said assessment is payable in seven (7) installments with interest at the rate of five (5) per centum per annum, on all installments from and after date of first voucher. All persons desiring may file objections in said court before said day, and may appear on the hearing and make their defense.
