GRAND JURY'S REPORT FLAYS COMMISSIONER'S OFFICE FOR VIOLATING LAWS.

IRREGULARITY **EVERYWHERE**

Declare Officials Lax in Preventing Tampering with Panel Lists and Other Matters-Boosts State's Attorney Wayman for Governor.

Chicago, Oct. 28.—Flat charges of fraud and wholesale violations of the law were made against the Cook county jury commissioners' office by the October grand jury, which adjourned following the presentation of an official report to Judge Tuthill.

Without mincing words or glossing over the accusations in any way the inquisitorial body declared the jurydrawing system "rotten and corrupt" from top to bottom. Conditions have been such the report alleged, that any commissioner or any employe in the office could pick out a grand or petit jury whenever he so desired.

Surprising Feature, A surprising feature of the report was the resolution made by the grand jurors personally, literally launching State's Attorney Wayman's candidacy for governor. The grand jury members wished him success to the degree that he would be entitled "to the highest reward of the people of the state of Illinois," which was taken to mean the governorship.

As for details of the venire system, the grand jury reported bogus cards, false lists and irregular proceedings in evidence. Capt. Roswell H. Mason, the chief clerk, is charged with having failed to place cards in the jury box after they had been selected, keeping them on his desk for long periods of

That one commissioner-name not mentioned—gave certain names to one of the employes of the office to be selected for jury service is charged in the report.

POLICE SHOOT DOWN TWO MEN. Caught in Act of Robbing Residence-Thieves Put Up Fight.

Indianapolis, Ind., Oct. 28.-Two men caught attempting to rob a house at 507 South Harris avenue were shot by Bicycle Policemen Mullen and Stewart in a desperate running battle. One of the men, who is probably fatally wounded, is named Mike Foley, according to his companion. The latter, shot in the leg and the arm, gave his own name to the police as Samuel Cardwell of Chicago. He met Foley, he said, at Cincinnati a few days ago.

The policemen were called by neighbors, who found Cardwell and Foley ransacking a house. When the policemen arrived the two robbers were in the street and at once opened fire. Mullen stopped his bicycle so quickly Lying there he returned the fire, and Stewart also began shooting.

The robbers, emptying their revolvers, ran, the policemen after them. Mullen followed Foley into a shed. The man had been shot through the ing.
