Boil The Water

A timely warning comes from the Board of Health relative to the condition of the lake water. It is bad and in all probability will remain so until after the spring rains.

Poluted water is responsible for many diseases among the most serious being typhoid fever, and as several cases have been reported just outside the city it behooves us to use the best methods known to keep it from becoming epidemic. So boil the water.

No Cause For Pessimism

The year 1909 was one of almost uninterrupted victories for temperance. In Indiana and Ohio anti-saloon elections drove the drink shops out of the country and smaller cities. Twenty counties of Michigan went "dry," and this is but a beginning.

These triumphs in the United States have been paralleled by similar progress abroad. New Zealand chronicles a great advance in the recent local option elections. Norway reports gains. Iceland and the Faroes have become prohibitionist. The five weeks' national prohibition and the overwhelming popular trial vote in favor of a permanent prohibition law show what we are to effect from Sweden.

Dwellers in Glass Houses

Billy Sunday leaves a town no better than he found it. He plays on the nervous sensibilities of people, and brings about an excitation which of necessity subsides and leaves the individual where he found him—or worse. The spiritual jag is no better than the one you get at the booze bazaar.

We greatly fear there is too much truth in the above quotation. We have never had the opportunity to study Billy Sunday's methods and the results at close range, hence would be slow to judge. But if the reports at

long range are at all reliable then there is much ground for Mr. Hubbard's criticism. We must not forget, however, that in spite of his many wise and beautiful sayings, Mr. Hubbard has never been noted for his reverential attitude toward the Christian religion.

And while, as we have admitted above, there may be some truth in Mr. Hubbard's criticism, it is far from being entirely true. It is not true that "of necessity," Billy Sunday's work "leaves the individual where he found him—or worse." So far as we can learn the results depend largely, if not entirely, upon whether the Church and Christian people follow up the work.

When about a year ago Mr. Sunday was closing his work in Springfield, he invited the Young Women's Christian Association to follow up, which they did; and as the result an association was formed numbering about 2,800 members. Similar results have followed in other places. Unquestionably Mr. Sunday sowed the seed; others cultivated the soil; both were necessary factors in the result.

Notice is hereby given to all persons interested that the City Council of the City of Highland Park, County of Lake and State of Illinois, having ordered that a cast iron lateral main water supply pipe, together with fire hydrants, valves and special castings to be constructed and laid along and under Sheridan avenue, Cedar avenue and St. Road, in the City of Highland Park, County of Lake and State of Illinois, connecting with the water main at the intersection of Linden and Lincoln avenues, and running thence southerly along said Linden avenue to Cedar, thence easterly along Cedar to Sheridan Road, thence easterly southerly along said Sheridan Road, and connecting with the water main laid in Roger Williams avenue, the plan for the same being on file in the office of the City Clerk of said city and having applied to the County of Lake County for an assessment of the costs of said improvement according to benefits, and an assessment thereon has been made and returned to court, the final hearing thereon had on the first day of March, 1910, or as soon thereafter as the bill of the court will permit.
