GOVERNMENT ATTORNEYS PLAYS TRUMP CARDS IN URION CONTEMPT CASE.

VACATION

Witness Shaw, on Cross-Examination, Bares Facts Not Hitherto Admitted in the Hearing-First Severe Blow for the Defense.

Chicago, Aug. 18.—Trump cards were played by the government in the hearing before Judge Kenesaw M. Landis of the case of Alfred R. Urion, chief counsel for Armour & Co., cited with three other Armour attaches to show cause why they should not be held in contempt.

W. W. Shaw, chief stenographer for the packing firm and one of the men cited with Urion, who previously has been the star witness for the defense, made what was regarded by the government attorney as damaging statements while under a merciless crossexamination by Assistant District Attorney James H. Wilkerson.

Defense Gets First Blow. This was the first severe blow dealt the defense since the hearing began before Judge Landis Monday, and its effect was noticeable in the ranks of attorneys representing the Armour interests.

That the government counsel ha something planned was apparent soon after court convened. Assistant Attorney General W. S. Kenyon, who came from Washington to guide the local government attorneys in the beef investigation, and District Attorney Edwin W. Sims were constantly conferring with Assistant District Attorneys Wilkerson and Ellis Godman during the early part of the court session.
