Conditions on which the bids were made... What these conditions were was not disclosed publicly; but the Board retired in the Clerks office and held an executive session to consider them, and when they resumed their open session adopted a motion to postpone the matter to the meeting on the 11th. The bids for the paving of the ten thousand lineal feet of streets in the Sylvan Newhall subdivision were then taken up. The three bids for this work were by: John Hays & Sons' Co., Neperville, Ill. John A. McGarry & Co., Chicago Thos. W. Kelly, Chicago.

The estimate of cost for this work was something over \$26,000. Mr. Kelly's bid was the lowest yet was more than \$3000 above the estimate. The Board considering all the bids much to high, declined them all, and directed that the checks of the bidders be returned.

Mr. Behrens had stated that the view of the delay and difficulty in securing a satisfactory right of way for the sewer system for the accommodation of his subdivision, Mr. Newhall did not wish the paving work let at this time, as the sewers ought to go in first. This statement doubtless had something to do with the action of the Board in declining to entertain any of the bids.

Following this action, President Hughes submitted a new recommendation and estimate of cost for a special assessment and condemnation of right of way were necessary, for this sewer system.

This was followed by the adoption of a resolution to carry out this recommendation and fixing the 18th inst. at the hour of 8 o'clock p. m. at the Council chamber at the time and place for a public hearing of the new sewer scheme.

The plan embraces some 250 feet of sewer in Green Bay Road west of the Northwestern tracks and also that part of Railroad avenue lying between Green Bay Road and the North line of the Northwestern station grounds.

At the meeting to be held on the 11th, the Improvement Board will resume consideration of the scheme to open a road from Snyder's Crossing to the north village boundary along the east side of the railways, and will have a public consideration of the other scheme to open a road from the Newhall subdivision on a line due west half a mile south of the County line through the farms of Beinlich, the Dietrichs and Schramms to the west village line.
