

Street and Alley Committee.

Communication from W. B. Smith concerning refund of taxes on Special warrant number 81 together with recommendation by the City Attorney of the payment of same.

Alderman McPherson moved seconded by Alderman Everhart that the matter be referred to the Finance Committee, which motion prevailed.

A letter from the Cameron Septic Tank Co. with reference to the construction of sewage disposal plants in Highland Park, was read and ordered placed on file.

The following communication addressed to Geo. A. Mason was read:—

October 31, 1910.

Mr. Geo. A. Mason, 200 Randolph St., Chicago.

Dear Sir:—

In answer to your letter of October 29th, I beg on behalf of the North Shore Consolidated Gas Company that we accede to you, suggestion that in lieu of the 10,000 cubic feet of gas per month previously offered by the Company to the city without charge, the company hereafter allow such free gas to the amount of 30,000 cubic feet per annum, and pay the city the sum of \$1000 to counterbalance the reduction in the amount of free gas allowed. Upon ratification of this adjustment by the Common Council, I will see that said sum is paid. The new offer of free gas, like the old, is non-cumulative that is, if gas is not used to the amount of 30,000 cubic feet in any one year, the difference is not carried over to the credit of the city.

It is, I believe, mutually understood that both the previous offer of 10,000 cubic feet of free gas per month and the new offer of 30,000 cubic feet per annum accompanied by the payment of \$1000 in cash, are voluntary on the part of the company. The new adjustment is made by the company in the spirit of fairness to compensate for gas not likely to be used under the old arrangement, and in appreciation of the harmonious relations between the two parties.

Alderman Bahr moved, seconded by Alderman Stevens that the City accept the proposition submitted by the North Shore Consolidated Gas Company and that the \$1000 to be paid by the North Shore Consolidated Gas Company be used in repairing and tarring of Green Bay Road. Carried. Ayes: Alderman Tillman, Kline, Everhart, McPherson, Stevens and Bahr. Nays: Alderman Doty.

Reports of City Clerk and Marshall were on the desk of each Alderman.

The following report of the Commissioner of Public Works was read: October 31, 1910. To the Honorable Mayor And City Council, of the City of Highland Park. Gentlemen:—

In the matter of the payment of \$176.80 on lots 167 and 170, South Highland Addition on the assessment for the south end sewer district, objected to by Mr. Carl Grant, I find that both of these lots have access to the sewer and are directly benefitted, although the sewer main does not run the full frontage of the lots.

A main sewer main starts about the center of lot 167 and runs northerly and another main starts about the center of lot 170 and runs southerly.

In making up an assessment, the property is assessed according to the benefit and if a lot has direct

access to the sewer it is benefitted as much as if the sewer ran the full frontage of the lot. The fact that it will take a longer run of pipe if the house is placed at one side of the lot is not taken into consideration.

There are a number of other lots in South Highland Addition that might have as valid a claim for reduction from the fact that the sewer, although running the full frontage of the lots, is in the ravine and necessitates a longer run of pipe to make a connection than is the case in the lots in question.

The assessment for the south end sewer was made up on the same plan as all other sewer assessments have been made, if a lot has direct access to the sewer, although the sewer does not run the full frontage of the lot, it is directly benefitted and pays the full assessment.

November 1, 1910 To the Honorable Mayor And City Council, City of Highland Park.

Gentlemen:—

Work of the County Line Bridge is progressing very rapidly considering the lateness of the season when the contract was let.

The contractor has all of the footings and walls in place and the columns are completed up to the bottom of the corbals, the steel all on the ground and practically all other materials delivered to the job.

If the weather will permit, the form will be in place by the first of next week, ready to pour the concrete and if nothing happens the bridge will be all in place within the next ten days.

I would therefore recommend, that the contractor Mr. Jay Rossiter be allowed an estimate of \$2,000.00 one-half to be paid by the City of Highland Park and one-half by the Commissioners of New Trier Township.

Monthly report of Justice Gail was read and ordered placed on file. Report of Fire and Water Committee Nov. 1, 1910.

To the Honorable Mayor and City Council, City of Highland Park.

Gentlemen:—Your Fire and Water Committee to whom was referred the matter of the furnishing of Glencoe with water, beg to report that they have investigated the matter and would recommend that the City of Highland Park furnish water to the Village of Glencoe under the following terms:—That a water main be con-

structed through the property of the Lake Shore Country Club, one-half of the expense of same to be paid by the City of Highland Park and one-half to be paid by the Village of Glencoe.

That the City of Highland Park contract to furnish water to said village of Glencoe at a rate of ten cents for the first five million gallons used, nine cents for the next five million gallons, eight cents for the next five million, seven cents for the next five million, and six cents for all over twenty million used annually.

Report of the Street and Alley Committee; To the Honorable Mayor and City Council.

Highland Park, Ill.

Sirs:—Your Street & Alley Committee report as follows:—Regarding the petition of the Ravinia property owners for the approach to the C & N W Ry., depot, this committee finds that practically all the obstruction to the approach to the C & N W Ry., depot, as complained of, is due to the grade and roadbed of the C & M. Electric Railroad Company which at this point are considerably above the natural road surface of South St. Johns Avenue, on which they are located.

This Committee being advised that this condition is unlawful recommend that the Board of Local Improvements order their engineer to at once prepare plans and specifications for the paving and otherwise improving of South St. Johns Avenue from the South line of Lincoln Avenue southerly to the southern terminus of St. Johns Avenue approximating the northerly line of the property known as Ravinia Park. That the City Clerk is hereby instructed to immediately upon completion of these plans, notify the owners and operators of all electric and other Railway Tracks at that time located on South St. Johns Avenue within the limits of the proposed improvements at once to raise or lower their tracks in such manner that the top or wearing surface of the rails will correspond with the road surface of the completed street. This committee also recommends the owners of any platform or other structure located in and in any way interfering with the free use of St. Johns Avenue be at once notified to remove same within ten days under penalty of their removal by the City.

This Committee recommends that it be given authority to order the placing of an incandescent Electric light at each of the two fills now being made on St. Johns Place and also an incandescent lamp to be located at the intersection of West Park Avenue and Homewood Ave. Respectfully Submitted, A.
