Village Board

There was a full attendance last Tuesday evening in both the Trustees and Local Improvement Boards. The session began promptly at 8 o'clock and ended ungrudgingly a little after midnight.

In the Trustees, a communication from Mr. F. H. Trude, of the Board of Health announced the resignation of Dr. Fred P. Patton as Health Commissioner and the appointment of Dr. E. M. Culver as his successor.

The engineers reported the Green Bay improvement, west from Snyder's Crossing, completed and recommended the acceptance of the work.

The matter of a change in the rates of the Electric Light Company, presented to the Board by the Company several months ago, was brought up again by a letter from Mr. Henry P. Pope to the President, Chairman O. S. of the Corporations Committee, to whom the matter had been previously referred.

Regarding the application of the Skokie Country Club for a permit for clay-pigeon trap shooting, President Hughes read a letter he had written to Secretary Copeland to the effect that he would give the Club a permit on certain conditions which he specified.

Payment of bills to the aggregate of \$2119.41 was authorized.

An ordinance to change the name of South Street to Woodlawn Avenue, prepared by the Attorney, was passed. South is the name of the an alleged unopened street along the east and west boundary of Jared Gage's subdivision.

When an extension of Woodland avenue from Lake street, west of the railways has been carried eastward to Sheridan Road, and it becomes proper the new name should be given legal recognition.

The most important event of the evening was the application of the Skokie Club for the vacation of sundry streets and parts of streets and alleys between South and Jackson avenues and of Valley Street along the east line of Block 36 between Park and Lincoln avenues.

President Miller presented drafts of ordinances prepared to effect the object of the petitioners. These were referred to Attorney Ramsay, who in a few minutes reported them to the board with some amendments, which were not objectionable to Mr. Miller.

For the sums thus shown due, it was ordered bonds be delivered to Swanson and Mortimer and a certificate to Delhays, the bonds for his work not yet being printed.
