The Man Across the Street

"Some have asked if there was any gambling at the fair this year. In response it might be said that there was none-the poor dupes who laid down their money had absolutely no chance of winning, as the operators of the games took care to see that outsiders did not win, as they might have done in an ordinary gambling game in which there is some element of

chance." The above is copied from an article in the Waukegan Sun as is the following:

"Rev. Thomas R. Quayle, secretary of the Lake County Law and Order league, was at the fair yesterday and looked into conditions quite generally. He seemed surprised at the number of gambling games but was pleased when he saw that the management was doing all possible to run them out as soon as they were found to be crooked."

In view of past exhibitions under the management of the Lake County Agricultural Association which are held each year at Libertyville under the title of the Lake County Fair the look of innocent surprise on the Rev. Quayle's face must have been wonderful to behold. Perhaps this was the first time the secretary of nicely now. the Lake County Law and Order League has attended the fair, in which case there is excuse for his surprise for one would hardly expect to find at an exhibition of this kind such a vast amount of gambling as the papers have reported. The article in the Sun further states that a number of games were run off the grounds because they were found to be brace propositions but gambling is gambling whether it is on the square or fixed and the best way to keep gamblers away from a county fair or any other public gathering is to refuse privileges for persons running gambling games or games that have the appearance of being gambling games.
