Rev. Van Evera and Rev. Schultze to Remain in This City

The pastor and Mr. Fred Botker have returned home from conference where some very delightful sessions were held. Rev. B. R. Schultze has been returned to his duties as presiding elder of the Chicago district and Rev. Van Evera as local pastor. Resolutions adopted at the conference which when passed by the General Conference will extend the length of time which a pastor may serve a charge from four to five years. The budget system of finances which is being so largely used by all progressive churches has been adopted. INSANE MAN DIES FROM EXPOSURE

Joseph Pfister Leaves Home Saturday and is Found Dead Monday

Leaving his home on South Second street early Saturday morning, Joseph Pfister, who has suffered from attacks of insanity for the past thirty years, wandered into the woods and in spite of the work of searching parties secreted himself so well that he was not found until Monday when a party of Italians discovered his body on the beach at the foot of Walker ave.

Mr. Pfister was sixty-two years of age, the son of Mr. and Mrs. George Pfister, and the aged mother survives him. Funeral services were held in St. Mary's church Thursday morning, interment being in St. Patrick's Curo-dor cemetery.

TRINITY CHURCH NOTES.

The special preacher on Wednesday evening March 25th, was the Rev. Edward S. White of Libertyville, a young man who was only recently ordained to the priesthood, having been graduated from the Western Theological Seminary a year ago. Mr. White has already done a remarkable work in this, his first parish and is destined to do much more important things in future.

The preacher for next Wednesday evening, April 1st, will be the Rev. Arthur Rogers, D. D., rector of St. Mark's Church, Evanston. Dr. Rogers is a scholar, an author of distinction and a man of unusual ability. It is hoped that the attendance at the 7:45 service next Wednesday evening will be large, and that those who can sing will sit in the front seats to help with the hymns.

Dr. Wolcott is to preach in Libertyville on Friday evening of this week, and on Monday next he is to give his annual lecture on the distinctive principles of the Episcopal Church to the students of the Young Men's Christian Association College in Chicago. He has also been asked to preach the commencement sermon on June 7th, at Racine College, an institution which he entered as a boy forty-four years ago and in which he remained for three years.

The subject of the rector's sermon Sunday next, Passion Sunday, will be "Facing the Facts." The Lenten Cantata "The Man of Nazareth" which was announced in last week's paper to be given on Good Friday is to be given instead on Palm Sunday, April 5th, at 8 o'clock p. m.
