the East Park District be requested
to acquire the title to the ground for
public use. Motion prevailed.
Mayor Hastings, who has been very
modest in asking favors of the Com-
missioners, requested to be allowed
to name a special commission for the
better protection of lives and prop-
erty in our city; a commission such as
the mayor of Chicago has, which
would in no way interfere with the
duties and privileges of the present
police force, the members of this
commission to act in emergencies, or
whenever the occasions command it,
this commission to be known as the
"Citizens' Co-operative Commission,"
each member to have a badge and
take oath of office; the request was
granted, and the following men nam-
ed as special police officers:
C. T. Boynton, John Oliver, R. S.
Kirchberger, John Udell and Clifford
Raymond.
Mrs. Fyfe as chairman of the Civ-
ics Commission and Dr. Ullmann, a
member of that commission, request-
ed that the duties of the Civics Com-
mission be more clearly defined so
that the members should in no way
interfere with other commissions or
step where they did not belong. It
was suggested that one of the duties
should be to receive all communica-
tions from the three Women's Clubs
of Highland Park and that a report
of the same be made at the council
meeting every two weeks. A full re-
port of the new national movement
known as "The United States Muni-
cipal Rifle Club, Highland Park Plan"
was given in the Sunday issues of
the Chicago daily papers and will be
found elsewhere in this paper so that
we need only to say that the name
of Highland Park will soon be mark-
ed in large letters on the map of the
United States of America instead of
being known as a small suburb of
Chicago. To Corporation Counsel
Holmes belongs the honor of having
worked out the idea, being based on
the plan of the Rifle Clubs of other
countries, more especially Switzer-
land, and to Mayor Hastings belongs
the honor of having realized the ad-
vantages offered in such an organiza-
tion, and of having carried these
plans to Washington and presented
them to the president; this explains
the calls from Washington to which
our honorable mayor responded dur-
ing the last few weeks; with wed-
ding bells in the air, we had imagin-
ed that perhaps he was expected to
act in an official capacity at the
forthcoming festivities in the nation-
al capital.

schoon keepers have evidently been
dropped as far as the city is con-
cerned since the council, at a special
meeting Tuesday night, refused to
take steps to revoke the licenses.
The evidence was gathered by two
men, Barron and Kupski, and sub-
mitted to Mayor Jolley in the shape
of affidavits tending to show that
they had purchased liquor on Sunday.
Arrests were made by Chief Lux and
the offenders arraigned Tuesday
morning. Two men plead guilty and
were fined \$50 and costs while the re-
maining seven plead not guilty and
appeared before the council. The
council discredited the testimony of
Barron and Kupski and vote four to
two against action of any kind.—
Times-Review.
