BOWLERS "WIND UP" SCHEDULE LAST FRIDAY

TWENTY-TWO WEEKS OF EXCITEMENT

Splitting of Prize Money and the Big Feed will End the Season. Enea and his Team Capture First Place

The only things that remain "undid" now concerning the bowling league is the splitting of the prize money and the big feed. The first annual league schedule closed last Friday night, and as a fitting climax to the twenty-two weeks of thrills and excitement this last night determined the winner. Capt. Enea and Captain Santi faced each other to determine who was to be champion. Enea and his men did the expected and won two games, just enough to "cop" first place. Santi, by losing the two games went into a tie for third place with "Red" Ori and Evans pulling up to a tie for second place. This was surely some tight finish. Until two weeks before the end of the season, McNanly and his "railroad" men looked to be certain winners. They were winning games with such regularity that no one seemed to be able to stop them. Enea and his "word beaters" took the heart out of them by taking three straight, and it was all over for Mac. Ori and "Doc" made a hard fight, but landed one game behind the winners. Three games difference between first and sixth place is some close. The other teams were pretty well bunched, which evidently shows six good teams and six "goat" teams. At any rate, everybody had a good time, and when next year comes, well we will wait till it comes.

The reason for Enea's success was merely the fact that he and his men usually got more pins than the other fellows. They hit the pins consistently all season, and stand first in team average with 802 for the sixty-six games. The nearest to this was 791 by Santi's team. In the three game averages Enea took first place with 907 and Santi second with 892. High team game also went to Enea with 998 and Ori with 946 second.

In the individual events many good scores were made. Tom Clark gets the most credit for his wonderful three-game series. Tom hit the pins for a 237 average, having games of 241, 248 and 221, a total of 710; Eddie Foy took second with 222. High single game went to "Cub" Moon with 277, but John Nizzi "almost" took this away, getting a 276 game. Ed Foy was third with 266.

League bowlers are anxiously awaiting the banquet. The date and place have not been set yet, but probably will be in a few days.

"Doc" Evans covered himself with glory last Sunday in Chicago when he rolled in the State Tournament. "Doc" got his ball working right away getting 267 for his first game in the singles. His second game was all that saved the present leader, for "Doc" came back and finished with 661, giving him a tie for fifth place. "Doc" deserves a lot of credit for his showing in this last tournament. He has had hard luck in previous tournaments, so here's to "Doc," the "guy" who came back.

The All-Star team from Highland Park got 2709 in the five men event, which places them among those who cash in. In the doubles, all Highland Park entries failed to make good.

ANNUAL REPORT OF ARDEN SHORE ISSUED

OUTINGS FOR 1539 AT CAMP LAST YEAR

Sixty-seven Convalescent Men were Provided with the Outdoor Treatment During the Past Winter. \$18,000 Needed

Arden Shore Association has just issued its annual report in the form of an attractive booklet. This big summer camp at Lake Bluff, the largest of its kind in the country, last year gave outings to 1539 women and children of the tenements, took them out of the heat and dirt of the city into the clean sunshine and the cooling breezes of the country.

The Association also carried on during the past winter an interesting and very successful experiment in keeping the camp open throughout the year and providing outdoor treatment for 67 convalescent men, who have thereby been rescued from weakness and possibly permanent incapacity and restored to health and productive industry.

The report contains a complete financial statement and shows that the annual amount needed to conduct the camp is approximately \$18,000.

Arden Shore has always been distinctly a North Shore philanthropy. Its officers and board of managers as well as the great body of its contributors are residents of the towns from Evanston to Waukegan. With its growing work and enlarging usefulness, this well managed camp makes a strong appeal to the people of this community.

REGULAR MEETING OF THE CITY COUNCIL

FREDERICK BARTLETT SUBMITS PLAT

Ordinance Passed Providing for a Water Main on First Street Between Laurel and Central Avenues

Mayor Hastings and four commissioners were all present at the regular weekly council meeting held on Friday last.

The minutes of the last meeting having been read and approved, business proceeded in the usual manner. Commissioner Hitchcock presented several small bills which were ordered to be paid, the other commissioners having no special business to bring before the council. Mr. George A. Mason, representing the real estate firm of Frederick Bartlett & Co., was given the floor. He submitted for the approval of the Council, a plat of the proposed subdivision, part of the Lytton tract, lying north of Roger Williams Ave., approximately 38 acres, part of which is inside the city limits, and part outside of it. Ravinia Highlands, south of Roger Williams Ave. being outside of the city limits, Bartlett & Co. had not consulted the city nor presented any plat, as no official interest was involved. Mr. Mason, speaking for Bartlett & Co., said he was afraid there had been a good deal of misapprehension and some ill-will regarding that plat. Mr. Merritt of the real estate firm in question had informed Mr. Mason that before the deed was filed in March, an attempt had been made to sell the entire holding in one acre lots; prominent citizens, some of whom are especially interested in the new golf ground in that vicinity had been interviewed but, with one exception, no interest was manifested. Mr. Watson, who owned the property known as the Watson subdivision, told Mr. Merritt that he, Mr. Watson, had made a mistake in trying to sell that kind of property in large lots, therefore these lots have been made up of smaller dimensions—already between \$90,000 and \$100,000 worth have been sold. Mr. Mason wished to bring to the notice of the council the fact that the property was being sold with certain restrictions. In the first place there was a building line restriction and, in the second place, a building value restriction from \$1,700 to \$4,000; another restriction was that no intoxicating liquor could be sold on the property nor could persons of African blood purchase any of the land. There was some comment. Mr. Mason understood, at the low figure for which this land was bought; it was sold cheap because of the fact that there were no improvements; he understood that there was an idea abroad that Bartlett & Co. were not definite in their statements to would-be purchasers. Mr. Mason wished to state that he had seen all the printed matter issued, and instructions were given to those persons acting as agents that they should inform the purchaser that the land is without improvements—there was no mystery about the fact—the cards were all laid on the table. Mr. Mason hoped that the Council would see fit, after investigation, to proceed in the customary manner in such a case; it was moved and seconded that the plat be handed over to Mr. Willits, Commissioner of Public Property.—Motion carried.

An ordinance concerning peddler's licenses reported last week was passed.

An ordinance was passed providing for a water main on First street between Laurel and Central Avenues.

As there was no further business the meeting was adjourned for a session with the Board of Local Improvements.

WHIRLWIND CAMPAIGN FOR HOSPITAL FUND

HEADQUARTERS IN SHERIDAN BUILDING

Miss Anne Bancroft Coughsane, an Efficiency Expert of New York, Has Been Engaged to Take Charge of the Work

Arrangements are under way for a Whirlwind Campaign, which will cover Highland Park, Deerfield and Highwood with Mayor Hastings as General Chairman, assisted by the Highland Park Hospital Association and Physicians' Advisory Board and the Mayor's Commission of Four Hundred.

\$60,000 will be raised by June 25th. This great project will be formally launched early in June.

The principle of the campaign is: (a) To fully acquaint the public with the purpose of the institution, with its history, the service it has given, its needs and its plans.

(b) To give to everyone a definite personal opportunity to have a part in placing the institution on a basis adequate to its needs and in keeping with the intelligence, the wealth and the public spirit of the people of the community.

(c) The method of the campaign is direct personal solicitation, preceded by a publicity program and the formation of a perfect organization of instructed workers.

Campaign headquarters have been established at the Sheridan Building, Rooms 8, 9 and 10, and will be open daily from 9 o'clock in the morning. As soon as the preliminary work is well under way the campaign headquarters will be open in the evening as well as during the day.

The campaign will be under the personal directions of Miss Anne Bancroft Coughsane of New York City, an Efficiency Expert of national reputation and a well known magazine writer, who comes to Highland Park after a series of splendidly successful campaigns in other communities. Miss Coughsane has raised over two and half million dollars for hospitals in communities from 7,000 to 600,000 in sums ranging from \$60,000 for Lewiston, Pa., to \$500,000 for the Belgian American Relief Fund during the past two years.

The Highland Park Press will keep the public in close touch with the progress of the campaign.

An important meeting of the presidents of the Women's Clubs, church organizations and societies of Highland Park, Deerfield and Highwood will be held at the home of Mrs. A. R. Carqueville on Saturday at 2:30.

Mrs. Francis D. Everett has been in touch with the majority of presidents this week, but in case any have been missed, it is hoped that all presidents or their representatives will make an effort to be present at this meeting. The Women's Organization will be an important factor in the campaign.

The Men's Organization will be made up as follows:

- Executive Committee.
- Initial Committee.
- Business Men's Division.
- Citizens' Division, and
- Young Men's Division.

The Campaign Organization will include residents of all sections, and all sections will be covered in the fund raising project.

The Highland Park Hospital will be a hospital for all, and it is the earnest hope of all men and women back of the project, that every resident of this vicinity will show a lively interest in its success.

Printed matter is now being prepared which will give the public complete information as to the plans for the new institution, and details of the forthcoming campaign.
