5. What interest did you receive from bank deposits, bonds, notes and mortgages?
6. What dividends did you receive from corporations?
7. What did you receive from life insurance policies?
8. What income did you receive from any partnership or fiduciary?
9. State income received from any other source.
10. What have you paid out in expenses to conduct your business?
11. What taxes did you pay?
12. What contributions have you made?

WE WON'T GET HOME UNTIL MORNING

And Many C. & N. W. Commuters of This and Other North Shore Towns Didn't

Suburban travel on the Chicago and Northwestern road Monday night was interesting, if not comfortable. Because of the fuel holiday all suburban trains for the north shore were cancelled between 5:45 and 7:01 o'clock; therefore considerable patronage developed for the 7:01. The would-be commuters, on reaching the Northwestern depot, found no train ready for them. They waited in patience until 7:35 p. m., when an incoming train having discharged its passengers, was commandeered into substituting for the missing 7:01 outgoing train.

The passengers piled aboard and then sat in the cold cars for an hour and ten minutes, waiting for a locomotive. Inquiry brought forth the statement that the engines were all frozen up in the roundhouse and that the particular engine which had brought the train in at 7:35 was out of coal, out of water, and out of commission.

At 8:45 a locomotive was finally found and was attached to the outgoing trains, and it started north. It was exactly one hour and fifteen minutes in reaching Hubbard Woods, arriving there at 10 o'clock.

Highland Park trains were likewise very late, causing much distress.

LOCAL POLICEMEN WORKING ON ROBBERIES

South End Homes are Entered During Owners' Absences. Suspect is Held

On January thirteenth the Highland Park police were notified that the George Pick home had been broken into. John Dieges, the caretaker turned in the alarm and later identified a man giving the name of Hans Christenson as being the person who was seen leaving the estate shortly after the robbery was committed.

The local policemen are working on the case. Christenson who doesn't deny that he entered the Pick home is being held at the county jail, Waukegan, awaiting the March term of the Grand Jury. He is charged with a number of robberies and has previous records in Chicago and Milwaukee.

Other robberies were committed within the last ten days. The victims are, Lessing Rosenwald, Isaac Meyer, J. McGregor Adams, E. Mandel.

As the families are all away, it has been difficult to determine just how much property has been taken. Local policemen believe that the loss was not great, however.
