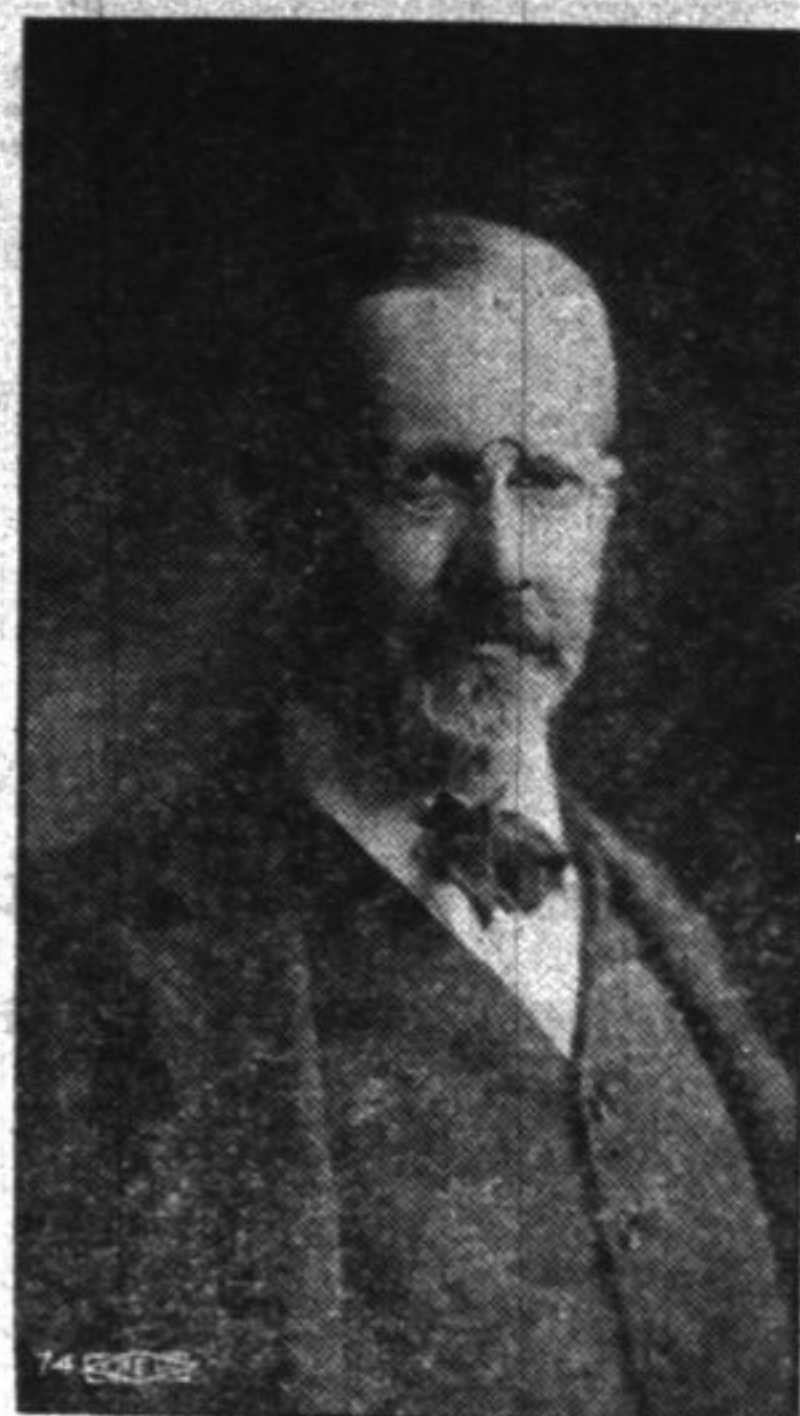

### AN ORDINANCE REGULATING THE MANUFACTURE, SALE AND SERVING OF DRINK AND FOOD-STUFFS.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF HIGHLAND PARK, LAKE COUNTY, ILLINOIS.

**SECTION 1.** Every firm, person or corporation owning or having in charge any ice cream parlor, soda fountain, restaurant, or other establishments dispensing, selling, offering for sale, manufacturing food or drink within the City of Highland Park shall keep such establishment and place of business, including floors, side-walls, ceilings, furniture, fixtures, receptacles, and implements in a clean, healthful and sanitary condition at all times.

**SECTION 2.** The doors, windows and other openings of such establishments or places of business during the period from May 1st to November 1st, of each year shall be fitted with self-closing screen doors, and wire window screens of not coarser than 14-mesh wire gauze.

**SECTION 3.** Food in the process of manufacture, preparation and packing and when stored, on sale or offered for sale must be securely protected from flies, dust and dirt; and food ready for consumption without further preparation, maintained or offered for sale or exchange in said establishments or places of business, shall be covered by some permanent means such as glass, wood, metal, pasteboard, paper or other suitable material, in such a manner or means as to adequately protect it from flies, dust, dirt or contamination.

**SECTION 4.** No sleeping or living quarters, water closet, privy vault, urinal, ash pit or coal bin shall be within the rooms used for the manufacture, storage or sale of food products in any such establishments or places of business, nor shall domestic animals be permitted to remain in such rooms.

**SECTION 5.** No firm, person or corporation shall permit any person or employee to work in such establishments or places of business dispensing food or drink who is afflicted with any communicable disease.

**SECTION 6.** In every such establishment or place of business there shall be provided convenient and ample washing and toilet facilities for the use of employees and such convenient and ample toilet facilities shall be separate and apart from any room, in such establishment or place of business, used in the manufacture, storage or sale of food products or drinks and such toilet or washing facilities shall at all times be kept in a clean and sanitary condition.

**SECTION 7.** No straws shall be permitted to be used in any such establishments or places of business wherein drinks are dispensed or offered for sale except when such straws are kept protected from flies, dust or dirt, and from promiscuous handling by employees and others.

**SECTION 8.** All soft drinks and like refreshments served from soda fountains and soft drink stands in any such establishments or places of business shall be served in individual paper cups or containers which said individual paper cups or containers shall be immediately discarded after use. All glasses, spoons, dippers, serving dishes or other utensils used in serving food or drink in any such establishments or places of business shall not be used a second time until they have been thoroughly cleansed with boiling water or live steam, or thoroughly cleansed in running water.

**SECTION 9.** Any firm, person or corporation who shall violate any of the provisions of this ordinance or refuse or neglect to comply with any requirements thereof, shall upon conviction be subject to a fine of not less than Ten (\$10.00) Dollars nor more than One Hundred (\$100.00) Dollars.

**SECTION 10.** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SECTION 11.** This ordinance shall be in force from and after its passage, approval and publication.
