### CLEVER SWINDLE CHECKED IN ZION

CARRIED ON LARGE SCALE

#### Messenger Boy and Chum Devised Scheme to Rob Chicago Mail Order House

Another three hundred dollars' worth of merchandise belonging to Montgomery, Ward & Company, of Chicago, was unearthed Sunday at Zion, according to a dispatch from the Zion correspondent of the Waukegan Sun. One of the most gigantic frauds ever worked on a Chicago business house was worked by an eighteen-year old messenger boy named Albert Stambach, employed by Montgomery Ward's wholesale house.

Stambach sent \$1,300 worth of goods to Zion alone, none of which was paid for, and accompanying almost every parcel was a refund check, that the recipient could cash at any bank.

And still the goods keep coming into Zion. Almost every mail—every express delivered brings in stolen goods from Montgomery Ward & Company. Stambach had an accomplice named A. W. Craig, who at one time worked at Montgomery Ward's. These two roomed at the same house in Chicago and they worked up a plan of shipping stuff out to Zion where Craig went and established a home at 2704 Emmaus avenue. After Craig left Montgomery Ward's he and Stambach conceived the idea of starting a store at Zion on a partnership plan. All kinds of goods were shipped out, including bedding, cases of canned fish, clothing—both men and women's, auto-tires, aluminum ware, silverware, sugar, syrup, amounting in all to \$1,300 worth—coffee, and a host of other things—and it seems as though there is more on the way.

Craig has a mother-in-law named Mrs. Marshall, living at 3110 Enoch avenue, and a lot of material was shipped to her address. The object was to furnish a flat free of cost for Mrs. Marshall's daughter, Miss Marshall was to marry a young man named Dolan, and he absolutely refused to have anything to do with the goods—looking on them with some suspicion.

Stambach evidently wanted to see Miss Marshall start out in life in good shape, for he sent out a lot of aluminum ware for a wedding present. Other presents were lavished on her.

Put Chicago Firm Wise  
Somebody at Zion wrote to Montgomery Ward & Co. and informed them that there must have been a mistake, that things were being dispatched to the house without having ordered anything. An investigation started, and the beans were "spilled." Stambach had been conducting a giant bogus mail order business on his own hook and had tried to implicate others by sending them a refund check with the goods, which they could cash without even sending back the goods. One man in California received a \$500.00 diamond ring with a refund check. He was to split fifty-fifty with Stambach. And so the fraud went on and on. Stambach and Craig are both under arrest and others may be arrested in the mixup before many days.

It is said that in one house in Chicago there was stowed up \$1,500 worth of goods which Stambach had sent out by fraud.

Deputy Sheriff B. Rielly and Mr. Loomis of Montgomery Ward & Co. drove out to Zion yesterday afternoon and took charge of an auto load of the stolen goods.

"For God's sake, isn't there some way to stop this stuff from coming?" said one of the Zion City men who has had a quantity of the stuff shipped to his address.

It is expected that it will be several days before the total amount of stolen goods can be traced.
