**BICYCLE RACES AT COOK COUNTY FAIR**

Large Number of Prizes Already Donated by Cycle Trades of America

The Cook County Fair Association in recognition of the increasing popularity of bicycle racing, has decided to put on quite an extensive program of bicycle events at the coming fair which will be held at Palatine, Illinois, September 13 to 18, next.

Bicycle races will be run on three afternoons of the Fair week, and will be sanctioned by the Amateur Bicycle League of America. A big list of prizes has already been donated by the Cycle Trades of America, while the Fair board will put up a silver cup and other trophies for the Cook County Championship race. Manufacturers of Chicago have also promised to contribute to the prize list.

The big race will be the One Mile Cook County Championship for a silver cup, and all the speediest Chicago boys are expected to be entered. Several novelty events in which bicycle riders will race against trotting horses are also on the program. Then there will be plenty of races for boys and girls of all ages as well as an event for old-timers of 40 or older. With the exception of the Cook County Championship event the races will be open to all riders, and dealers and clubs of the middle west are invited to send in their entries.

W. T. Farwell, Jr., has been appointed as manager of the race meet, and entries may be sent in to him, of Cook County Fair, 231 Northwestern University Bldg., 31 West Lake St., Chicago.

**ANTIOCH TO HAVE SPECIAL ELECTION**

**Councilmen Who Resigned Because of Speed Law Enforcement May Run Again**

Waukegan's new Masonic temple has been completed and arrangements are being made for the big informal opening which has been set for Thursday, August 25. **BOBBED HAIR PASSE**

Announcement Made Last Week at National Hairdressers' Association Convention in Chicago

Thank goodness we're to see the women's ears again — fashion molders in Chicago have announced that the latest word is that ears are to soon become naked again. Yes, it is announced with the noise of trumpets that the flapper who wears short skirts and rolled-down stockings with brazen indifference is finally blushing with outrage and modesty. She is forced to expose to the public gaze the ears that she has kept carefully concealed for many months. No more earmuffs of hair. No more bobbed locks. It has been decreed by fashion. The erstwhile cute young thing will, with the autumn, blossom into a dignified young woman, with hair piled high and a black frock, long sleeved and long skirted.

The startling announcement was ascertained in Chicago last week by visits to the annual convention of the National Hairdressers' association, that opened today, and the National Women's Apparel association, which will display fall robes at the Morrison hotel this week.

**Bobbed Hair Must Go**

"Bobbed hair is passe. The high dignified hairdress is the new thing," explained E. Rhode at the hairdressers' convention. "False hair is used freely, particularly when made into curls and attached to the high knot that is characteristic of the new headdress. And the ears must show. No more earmuffs, as they are called."

"American women are the most beautiful in the world," he continued. "They need individuality in hairdressing because of the divergence in types, and American hairdressers are going to help them develop it. Overseas fashions in hairdressing are not to be copied in this country. The Hairdressers' association is working toward Americanism in its line, just as the designers are."
