GOVERNOR'S SON TO STAY IN WAUKEGAN

TO REMAIN WITH FATHER

Small Family, However, Will Spend Much Time in Chicago; Other Lake County News

Leslie Small, editor of the "Republican," a daily newspaper at Kankakee, will be with his father, Governor Len Small, throughout the trial of the latter at Waukegan, it was learned last week. The governor's wife will not be in Waukegan much, if any, of the time during his stay there. If he leases a private residence in Waukegan, the governor will be there only a part of the time, and will spend most of his time in Chicago when not in court.

James McLean, alias Harris, was found guilty of larceny by a jury which returned a verdict in circuit court last week. McLean was charged with having stolen twenty large cartons from a "Soo" line train near Area. The cartons were valued at \$100 each. The cigarets were found buried in a fresh furrow in a plowed field in Fremont township, where they had been hidden.

The famous Cary slide of the Norge Ski club of Chicago, which was wrecked in a wind storm last summer is being rebuilt and made ready for this year's annual events. The new concrete foundation was completed last week and work of erecting the huge steel structure is well under way.
