Congressman is Candidate for Re-Election; Other Brief Items of Lake County News

Congressman Carl R. Chindbloom of this district last Friday filed his primary petition for re-election, on the republican ticket at Springfield. Others who will oppose him filed as follows: Daniel J. Blaul and Ralph W. Nordlie, (rep.)

J. T. Conrad, chief petty officer at the Great Lakes naval training station, was seriously injured Wednesday of last week when the automobile in which he was riding collided with a truck on Sheridan road between Thirteenth and Fourteenth streets.

Judge C. C. Edwards last Friday adjourned the circuit court until March 6, when the trial of Gov. Len Small, charged with conspiracy to defraud the state of interest money, begins. Judge Edwards and his wife left this week for New Orleans where they will spend a ten days' vacation.

The Illinois Supreme court last Friday denied rehearing to E. V. Orvis and other taxpayers of Waukegan in the case in which the Supreme court reversed and remanded the judgment of the County court of Lake county. The County court had sustained the objections of the taxpayers to the thirty per cent increase in the assessment of lands and improvements in Waukegan made by the board of review of Lake county.

Three people were injured, one probably fatally, when two automobiles crashed together opposite the cemetery in Zion last Friday night about 11 o'clock.

Commercial fishing in Waukegan has been practically at a stand still for the last few months but is now beginning to pick up and within another week or ten days it is expected it will be flourishing—that is, providing the weather remains favorable.

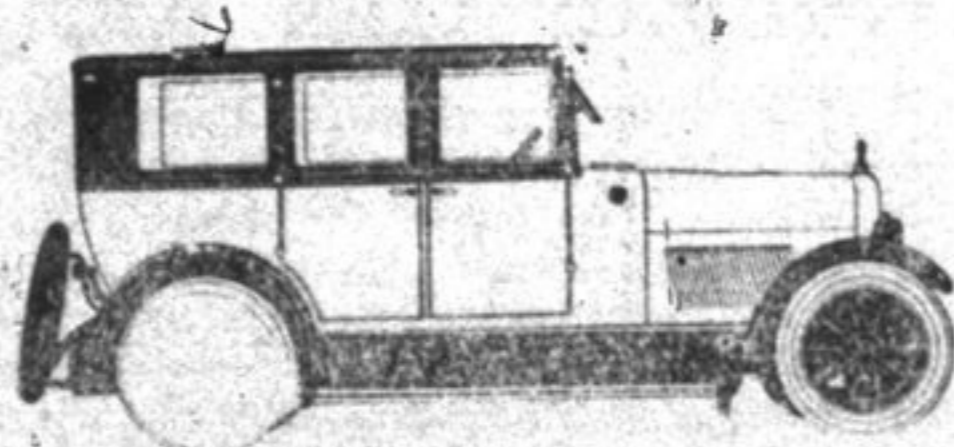
