

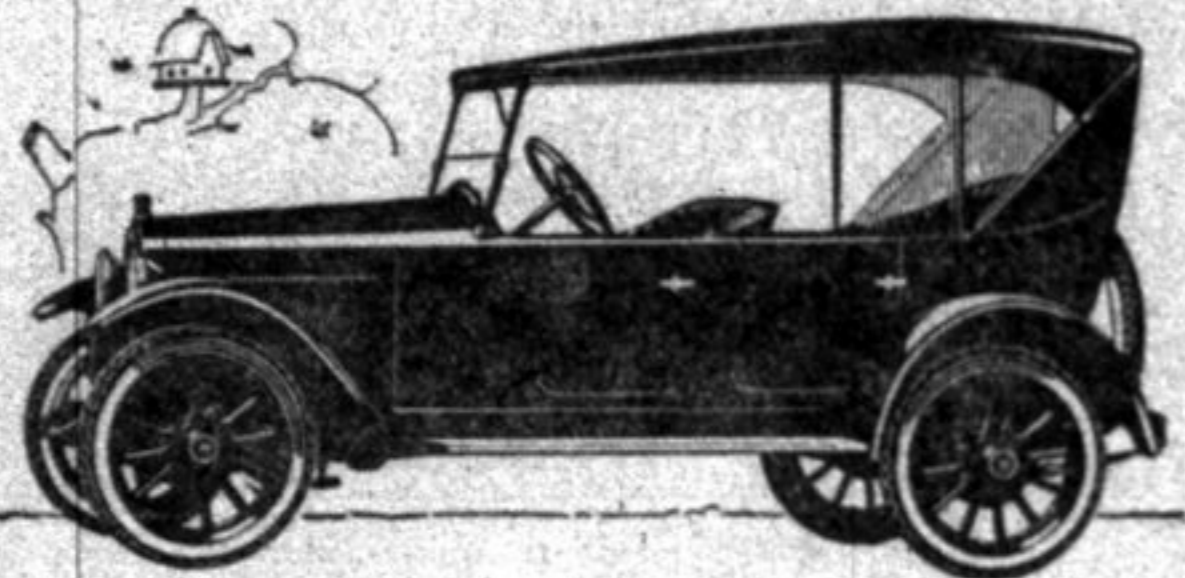

### BAR ASSOCIATION WANTS NEW DISTRICT

#### Winnebago County Lawyers Propose Move Which Would Effect Lake County

Rockford. — Creation of a new Circuit court district in northern Illinois with Winnebago and one other county comprising it, is proposed in a resolution passed by the Winnebago County Bar association at its meeting in Rockford. A committee was appointed and instructed to report to the association at a future meeting plans for the carrying out of this program. Resolutions were also passed condemning the proposed action of the state constitutional convention redistricting the state supreme court districts of Illinois, and suggesting that the laws of the state be amended in order that a circuit judge in Illinois may certify civil cases to the county court which are within the jurisdiction of the county court.

Committees were named to consider these resolutions and report to the bar association at a future meeting.

#### Need More Judges

The work of the circuit court for this district is too heavy, as the district is now constituted, for three judges. For that reason, the Winnebago County Bar association favors the creation of a new circuit district with Winnebago and one other county, probably Boone, comprising that district.

This circuit court district, as it is now constituted, consists of the counties of Lake, McHenry, Winnebago and Boone. The work for the circuit court in Winnebago and Lake counties is very heavy. The work of the court in the other two counties in the district is much lighter. There are now many cases on the circuit court docket in this county which have been on the docket for from one to two years. Since Judge Welsh went on the bench many of the old cases have been tried and taken from the docket, and, although Judge Welsh has worked almost continuously for twelve months each year, it has been found impossible to get the docket anything near clear of the old cases. It is argued if Winnebago county were attached to some other county in a circuit court district, three judges could clean up the dockets and keep them up to date, thereby being able to give more speedy trials than is now the case.

Of the other counties in this district, as it is now constituted, Lake county has the heaviest circuit court docket aside from Winnebago. Judge Claire C. Edwards is not able to clean up the court docket for his county, much less give much assistance to Judge Welsh in his county. Judge E. D. Shurtleff, the other of the three

judges in this circuit, goes from one county to the other in the circuit giving such aid as he can to Judge Edwards and Judge Welsh. But the combined efforts of the three judges are not sufficient to clear the dockets of the circuit courts of the four counties.
