THOUSANDS ATTEND ELKS CELEBRATION

BALL GAME A FEATURE

Many Participate in Festivities at Sunset Wood on Fourth; Address by Mayor Hastings

A "glorious Fourth" was spent by more than two thousand people at the B. P. O. E. celebration in Sunset Wood Tuesday.

The festivities began at 10:15 when the Chicago Woman's band arrived from Chicago. After a parade through the business district the crowd proceeded to Sunset Wood.

Mayor Samuel M. Hastings made a short talk at the park about eleven o'clock. He spoke of the bloodshed in the recent "mine war" in southern Illinois, and deplored the fact that such things should occur in supposedly civilized communities. The mayor went on to speak on the subject of "Our Flag." He said in part:

"I wish that every American citizen—every man, woman and child in the nation—could feel and realize that he is a part of the United States; that he owns a portion of every public building and of every other public property in the land; that his interest in all things pertaining to our country is the same as that of every other citizen, no matter how poor or how rich he may be.

"If each one of us Americans could feel that he was a part of the great national family, and that whatever he did—good or bad—had its influence and wrought its results in the home of the nation as well as in his own humble cottage or costly mansion; if we all could get this feeling of proprietary interest and responsibility, how much better citizens we should be.

"The Flag that represents our nation holds out the hope and promise of this great country to every child born in the air of Liberty. Every American should be taught what the Flag means, what it stands for and an undying and holy love fostered for the Flag that has never known defeat, which means comfort for the afflicted, justice for the oppressed, and the divine right of liberty in man."

NO STRIKE EXPECTED ON NORTH SHORE LINE

Difficulties Between Company and Employees Are Being Straightened Out

Differences between the North Shore line and its employees are being ironed out this week. A conference was held in Chicago yesterday between officials of the company and representatives of the employees. It is expected that the matter will be settled within a few days. Those who are the best acquainted with the circumstances are emphatic in their assurance that there will be no walkout.

The difficulty concerns the new wage agreement, submitted by the company, which proposes a five per cent decrease September 1, and an additional five per cent decrease January 1. Officials of the company point out that the loss to the North Shore line as a result of the decrease in freight rates will amount to about \$75,000 a year.

PROSECUTOR OPPOSES GOV. SMALL'S VETO

Appears Before State Pardon Board and Argues for Death for Potz

Col. A. V. Smith, state's attorney of Lake county, appeared before the state board of pardons at the Great to oppose commutation of the death sentence of Ignatz Potz, who shot and killed Motorcycle Policeman Peterson of Winthrop Harbor last winter.

Potz was to have been hanged in the courthouse at Waukegan during the trial of Gov. Len Small, but the governor granted a sixty-day stay of execution. And last week the governor announced that he had commuted the slayer's sentence to life imprisonment. He said he had done so because that was the last request of Mrs. Small.

State's Attorney Smith said Tuesday he had taken no initiative in the matter after the announcement but had received from George D. Sutton, the governor's secretary, a telegram asking whether the prosecutor wished to be heard by the pardon board on the subject of the commutation. He replied he would speak.

BOY ARRESTED; HE ROBBED BOB O'LINK

Thomas Graff Held Over to the Grand Jury on Second Offence

Thomas Graff, 15 years old, 2938 N. Fairfield avenue, Chicago, has been held over to the grand jury on charges of robbing the Bob O'Link golf club. He was arrested last Friday at Hodgett by Detective C. G. Newman, who found that the boy had a revolver and 148 golf balls in his possession. He was taken to Waukegan, and later turned over to the Highland Park police. The youth at first claimed that his name was John McNeal. Later he confessed.

Graff was picked up by the local police several weeks ago for robbing the Bob O'Link club. His parents promised that the deed would not be repeated, the boy was released.

NO LONGER TRAIN SEAMEN AT STATION

The Great Lakes Naval Training station will cease to function as a training place for seamen, and will be continued only for the training of specialists in radio and navigation work according to word received from Congressman Carl R. Chindblom Saturday. Furthermore, only \$200,000 has been appropriated for maintenance of the station for the coming year, as compared with \$400,000 this year.

The Great Lakes station is the hardest hit in the slashing of appropriations for naval upkeep. Only one other station received an increase and only one other received the same appropriation as this year.

SCHNEIDER NAMED FOR POSTMASTER

MADE 82 IN EXAMINATION

Congressman Chindblom Recommends Present Assistant for Head of Office in This City

Assistant Postmaster Hugo L. Schneider made the highest mark in the examination for postmastership in Highland Park with a mark of 82.20, according to a communication received by the Press from Congressman Carl R. Chindblom at Washington. Mr. Schneider has been recommended for the position, and it is expected that his appointment will occur in a few days. Postmaster William M. Dooley was second in the examination with a grade of 78, according to Mr. Chindblom. The letter follows:

The Highland Park Press, Highland Park, Illinois. Gentlemen:

I have just advised Mr. William M. Dooley and Mr. Hugo L. Schneider that the U. S. Civil Service Commission on the 28th ultimo announced the result of the examination for postmastership at Highland Park as follows: Hugo L. Schneider, 82.20; William M. Dooley, 78. In view of this and other circumstances I have recommended the appointment of Mr. Schneider and expect his nomination to be made by the President and confirmed by the Senate within a week or ten days. I hope this appointment will be agreeable to the people of Highland Park and to the patrons of the post office.
