C. N. S. & M. EMPLOYEES TO VOTE ON OFFER

COMPANY PROPOSES CUT

Officials Demand 3 1/2 Per Cent Reduction at Conference Thursday; Meeting at Highwood Tues.

Employees of the Chicago North Shore & Milwaukee electric railway will act on the new wage proposal of the company next Tuesday evening in Highwood.

Decision to call for a special referendum vote on whether or not to accept the wage reduction ordered by the company was reached Tuesday night by 750 union employees at a meeting in Highwood. The opinion prevailed that the men would not submit to a decrease.

The meeting Tuesday night followed a series of conferences between representatives of the employees and President Budd, at which President Budd submitted a proposal cutting the pay from 73 to 70 cents an hour on Sept. 1. This cut, based on the entire year, amounts to about 3 1/2 percent. The previous offer by the company, which was turned down by the union, called for a 5 per cent cut on Sept. 1 and another 5 per cent on Jan. 1 next. The new proposal covers the one reduction.

The agreement which is pending, if signed, will be effective for one year.

Although the general opinion is that the employees will reject the latest offer of the company, it is believed that the matter will be settled by arbitration, and that there will be no strike. Both the employees and the officials of the railroad have shown themselves to be willing to thresh out their difficulties by arbitration.

"DIDN'T GET SQUARE DEAL"—SAYS SMITH

Believes That Pardon Board Was Guided by Governor In Potz Case

"I do not think I was given a square deal, and I do not think Lake county got a square deal," said discussing the commutation of sentence for Ignatz Potz who is being taken to the state penitentiary at Joliet to serve a life sentence for the murder of William Peterson.

"The pardon board took less than 24 hours to review the Potz case, and their recommendation was made to the governor almost before I could return to Waukegan.

"Gov. Small has the power to do this, and evidently his mind is made up to allow Potz his life even though he, an immigrant, murdered Peterson, an American soldier and an officer of the law.

"I could hardly expect anything more from the pardon board, but I did think they would go over the case thoroughly and know the circumstances. They are personal appointees of the governor, and his word is the law. I believe he has used his power for sentimental reasons that should not be considered in this case. He has reversed the decision of a jury of twelve men, Judge Edwards, and seven justices of the supreme court."

WM. BREMER HONORED AT CAMP EBERHART

Local Man Elected Vice-President of Corey Valley Country Club

At the election of officers of the Corey Valley Country club, June 30, William Bremner was made Vice-President of the club. This club is located at the South Bend Y. M. C. A. The ground is naturally rolling and makes an ideal course for golf. Mr. Elmore says that it is one of the sportiest little courses he has played on.

Max Greineder, former owner of the Chateau Maxim, a roadhouse south of Highland Park on Green Bay road, pleaded guilty to violating the Mann act, and to a charge of smuggling Tuesday before Federal Judge George A. Carpenter in Chicago. He was ordered held in the custody of the United States marshal for one day and fined \$300. Greineder was arrested in connection with an alleged conspiracy in which he is said to have smuggled Miss Ann Herzog, an Austrian refugee, into America, with her jewelry, valued at \$30,000.
