### MAJOR BRADLEY INJURED IN AEROPLANE ACCIDENT

#### Shaft Breaks 5000 Feet Above New York City and Forces Landing

Last Monday morning the "Chicago Tribune" reported that Major Bradley, the brother of Mrs. Frank Fitt, well known to many Highland Parkers, had been fatally injured in an aeroplane accident over Brooklyn, N. Y., in which a brother officer lost his life.

The account of the accident was substantially correct. Fortunately Major Bradley's injuries, while serious, are not fatal. Several ribs and an ankle were broken. He was badly bruised but suffered only slightly from shock. He is convalescing at the Bushwick hospital in Brooklyn.

According to the newspaper account Major Bradley was in command of a Martin bomber carrying six men. When the shaft broke the aeroplane was flying over New York City at 5000 feet. With his power shut off Major Bradley was obliged to make a forced landing. He brought the machine to earth in Brooklyn and some obstruction overturned it. "The four men in the rear cockpit escaped without injury. Lieut. Smith was killed and Major Bradley was injured.
