

SALE OF OBJECTORS PROPERTY ORDERED

RESULT COURT DECISION

County Treasurer Authorized to Sell Realty Affected in Recent Tax Case From North Shore

County Judge P. L. Persons last week approved the application of County Treasurer Ira Pearsall to sell a large amount of Highland Park real estate the owners of which fought objections to the Supreme Court, where they were defeated in seven of the eleven objections these being among the most important issues involved so far as the county is con-

The order of Judge Persons is in accordance with a mandate issued by the Supreme court recently which was remanded back to the local court for entry of judgment against the property.

The case was brought against the county treasurer by George D. Mc Laughlin and other of Lake Forest and Highland Park restraining the treasurer from collecting the taxes included in the 30 per cent blanket increase of the board of review, on the claim that it was illegal, and they made a like objection to their portion of the \$1,000,000 road bond issue, besides several others. In the county court a number of objections were sustained and others were overruled. Both the county and objectors took appeals to the Supreme court on the points in which they were defeated, respectively. The Supreme court issued a mandate sustaining the county in the most important points, with the result that the county treasurer now can demand payment of about \$85,000 in back taxes or sell the property, under the order of Judge Persons.

SAFETY OF WORKERS SAFEGUARDED WELL

BY PUBLIC SERVICE CO.

Methods of Reviving Those Who Are Injured Also Studied and Employes Trained in First Aid

The Public Service Company devotes great attention to the safety of its employes especially those engaged more hazardous work. It has a reg ular safety organization and carries on a constant educational work instructing men how to avoid unsafe practices. Methods of reviving and resuscitating persons victims of accident have been evolved by the electrical and gas industries generally and these in practice prove effective. First Aid Work

So familiar have many Public Service men become with these methods that they have more than once been called on by local municipal authorities for service which they are always ready to give. Recently two children in a town served by the company, were overcome with gas from an open jet. The local experts were unable to resuscitate them but a lineman in the company's employ did so.

The company is extending the scope of its safety bureau. It will shortly begin training all employes so they may be prepared to render first aid in case of emergency. The course to be established will include tuition in methods of applying bandages, splints, etc., and the application of tourniquets to check bleeding. The first team will consist of twenty employes who will be trained in Chicago under the supervision of a qualified director, As soon as the course of this team is completed, others will be organized.

Training Employes It is hoped that within one year each of the male employes of the company will have received a course of training in first-aid work. As the work progresses, it is planned to select a team of twenty men to act as the company's exhibition first aid team. This team, of course, will be uniformed, and will be entered in competition with teams of other companies, including the Elevated system, Commonwealth Edison Company, Peoples Gas Light & Coke Company and the Chicago Telephone Company.
