OBJECTIONS FILED TO TAXES LEVIED

FROM THIS CITY

Nearly 200 From Highland Park and Lake Forest, Besides As Many Others Are Objectors

More than a score of petitions were filed in county court Tuesday protesting against taxes, the objectors aggregating approximately 400, Highland Park, Lake Forest, Zion and Winthrop Harbor being the source of most of the protests, but there were a number of others, including the Roman Catholic property at Area and Am Echod congregation, Waukegan.

The objections run up into several hundred thousand dollars, most this being on property in Highland Park and Lake Forest.




