GLENCOE PLANNING WATER WORKS PLANT

BOARD PASSES ORDINANCE

Plans and Preliminary Work Completed; Description of Undertaking Given; Site

An ordinance authorizing a water works system for the village of Glencoe and providing for payment for the improvement was passed by the village board last week.

Plans and specifications for the system have been prepared by Alvord, Burdick & Howson, hydraulic and sanitary engineers and provide for the following elements and constituent parts:

A submerged crib, intake pipe, suction well, four low lift pumps, two concrete mixing tanks, coagulation basin in two compartments, eight filters, clear water basin, four high lift pumps, superstructure enclosing filters and equipment and a wash tank, together with piping, miscellaneous equipment and appurtenances.

An initial construction and installation which shall have a unit capacity of 3,000,000 gallons per day is provided, three of the high lift pumps to be driven by electric motor and one by gasoline engine.

Site at Foot of Park The site of the proposed water works system is on the shore of Lake Michigan, north of and adjoining the north line of Park avenue.

Provision also is made in the ordinance for enlarging the plant, whenever the demand exceeds the 3,000,000 gallon per day capacity mentioned in the foregoing.

DEMONSTRATE WORK IN FIRST AID LINE

North Shore Line Employees In Fine Exhibition of Efficiency Recently

The high degree of efficiency in first aid and safety work attained by employees of the Chicago North Shore and Milwaukee railroad was publicly demonstrated when 30 picked experts engaged in competition for company championship honors at the parish house, Waukegan, Jan. 27.

Before an audience of 500, five teams representing various departments demonstrated their skill in meeting emergencies and showing "what to do before the doctor arrives."

An average of 97 per cent was made by the mechanical department team in six problems; one of the highest ever recorded in a contest of this kind. This team, however, was forced to extend itself to win the championship honors by the skillful work of the electrical department team, which completed the scheduled five problems with a score that tied the mark of the mechanical department representatives.

The contest was held under the supervision of the American Red Cross, which organization furnished the judges and a first aid medal to each member of the winning aggregation. A North Shore Line trophy also was awarded to this team.

This program marked the conclusion of a record year in first aid training activities among the North Shore Line employees. A total of 135 members of the personnel were graduated during 1926. These will receive Red Cross diplomas certifying their completion of the course at a banquet to be held at the Hotel Sherman, Chicago, on Feb. 24.

GOVERNOR SMALL HAS ESTABLISHED RECORD

In Number of Appointments in Twenty-four Hours; Names Over 56,000

That Gov. Small has established a world's record for the number of appointments made within 24 hours is the belief of several members of the Illinois legislature.

Up to midnight Wednesday, the state executive sanctioned the appointment of 56,021 persons all of which are awaiting confirmation by the state senate.

The first batch was made up of 56,000 commissions issued to notary publics of the state for which the state receives \$2 each. The law provides that all of these appointments must be sent to the senate. The 21 other appointments were for various state offices.

ALLEGED FORGERS TAKEN IN COUNTY

TWO ARE UNDER ARREST

One From Libertyville and The Other Chicago; Latter Is Captured by Lake Forest Police

A confession made by Irving Smith, Libertyville forger, to Sheriff Doolittle and Deputy Sheriff Tom Tyrell, last week disclosed the fact that the man had forged checks to the amount of \$83 at several stores in Libertyville, according to reports from the sheriff's office.

The man is said to have admitted purchasing a \$5 pair of shoes at the store of John Cole, giving him a check for \$12. He also passed checks and procured merchandise and change for them at the stores of Ray Smith, Max Koner, Jay Morse and Bradford's. The checks were cashed Saturday night within an hour and were signed by a Mr. Miller, who Smith stated was his employer.

Judge Newcomb of Libertyville, bound Smith over to the grand jury.

The Lake Forest police last week arrested a Chicago man, believed to have been cashing forged checks extensively on the north shore, and who, according to Chief Lester Tiffany, has already confessed to forging and cashing four checks amounting to \$160, each for \$40. He gave his name as Charles Mason, 38 years old, of 1215 Draper street, Chicago, and said he was the father of two children. He was held.

Mason was arrested at his home by Policeman Jack Dunn, who waited in the neighborhood for him for some six hours. A description furnished by one of the Lake Forest merchants swindle led to the arrest of Mason.

Mason was formerly employed in Lake Forest as chauffeur for B. S. Harvey. He is alleged to have forged Harvey's name to the checks. The \$40 checks were cashed at the following stores, small purchases being made at each place:

J. J. Kennedy, Lake Bluff garage. S. E. Burkey, owner of a butcher shop in North Chicago. Robert Marshall, manager of the A. & P. store in Lake Forest. Hunt and Zimmerman hardware store in North Chicago.

The checks were all payable on the Citizens State Bank of Chicago and were cashed on January 8.

McHENRY WILL VOTE ON PARK PLAN FEB. 19

Tract Proposed Includes All Land in County Along Fox River

Whether or not McHenry county is to establish a vast park in its beautiful lake region will be decided at a special election Saturday, Feb. 19. This is the date that has been set by the county judge of that county.

At the same time the citizens vote upon the park, they will vote upon the selection of five park commissioners, to have charge of the project if it carries.

Planners of the district have incorporated in it forty square miles of lake, river and adjacent property. This includes all of the land in McHenry township bordering on the Fox River and Pistakee bay and McCollum's lake, and fourteen square miles in Nunda township bordering on the Fox river and including Griswold and Lily lakes.

Being an unusually large district, ample funds will be available for the purchase of land for park purposes and the annual tax levy, with the additional income from concessions, will provide sufficient money to pay for park maintenance and the employment of officers to police the district.

SENATOR SWIFT'S SCHOOL NURSE BILL

Senator Rodney B. Swift, Highland Park, last week introduced a bill in the state senate which would amend the free school act of the state to authorize boards of school directors to employ school nurses and prescribe their duties. The bill was referred to the committee on education, and will probably be passed, claim leaders in Springfield, after committee action on it.

The bill presented by Senator Swift is the only measure that has been offered so far by the delegation from the eighth district.

It is predicted, however, that when the legislature reconvenes next week, the representatives from the Waukegan region will have several bills in preparation for introduction.

Representative William F. Weiss, Waukegan, will again head the committee on education, according to the leaders at Springfield, when the house bodies are named.

NOT TO INCREASE FARM LAND TAXES Committee of Assessors In Meet So Decide as to West Part of County

Farm lands through the western part of the county will not stand an appreciable increase in taxes for 1927 the committee of assessors from the west half of the county decided last week at their session at Libertyville at which Y. C. Ray, Libertyville township assessor, was chairman.

Truly farm properties will remain about the same while farms converted to subdivision purposes must stand a justifiable tax, they determined.

It was agreed that there should be a small increase on village and town lands but not greatly out of proportion with the past year. This being revaluation year, the scale, which will endure for four years, is being arrived at very carefully with the hope of reaching a just tax.

Treasurer Roy Bracher was at the conference and will also attend the one that is slated to be held by the assessors of the eastern half of the county. Charles O. Arnes, Waukegan township assessor, is chairman of this body. Then the two branches will hold a joint meeting and reach a final decision.

MAN FOUND DEAD AT LIBERTYVILLE Body of Edward Nelson Is Discovered in His Shack by Marshal

Edward Nelson, 65 years old, a laborer who had been employed in odd jobs about Libertyville for several months, was found dead in his shack at noon Friday. He had evidently been dead for several hours when found and death is thought to have been due to heart trouble.

He was employed by Fred Cole of Libertyville, and was to have returned Friday morning to complete his work. When he failed to put in an appearance Mr. Cole went to the shack, located near the village septic tank, where Nelson had been living alone. Cole was unable to effect an entrance as the door was locked from the inside and called Marshal Libbey who forced an entrance and found Nelson lying dead on a cot.
