Mr. Benjamin F. Lewis Highland Park, Illinois. Dear Sir:

We understand the question to be as to whether or not the City of Highland Park may employ a person trained and experienced in Municipal Government to aid the Mayor and the Commissioners. We further understand that there is no intention of relieving the Mayor or any of the Commissioners of any of their authority or responsibilities.

The Act providing for a Commission Form of Government provides for a Mayor and four Commissioners. The Mayor is to act as the Superintendent of the Department of Public Affairs and the Commissioners are to act as Superintendents of the departments of (1) Accounts and Finances, (2) Public Health and Safety, (3) Streets and Public Improvements, and (4) Public Property.

Section 25 of the Act provides in part as follows:

"The council shall have the power by ordinance, from time to time, to create, fill and discontinue offices and employment other than herein prescribed, according to their judgment of the needs of the city or village."

The above quoted provision must be read in connection with the general principle of law that discretionary duties given to Municipal Officers

by statute cannot be delegated. However, the statute, in our opinion, would authorize the city to employ a person trained and skilled in Municipal Government, whose duties would be to keep informed as to the conditions and needs of the city, to advise the Mayor and the Commissioners of these conditions and needs, to make recommendations if requested by the Mayor and Commissioners, and to carry out the directions of the Mayor and the Commissioners.
