NO THOUGHT WAS GIVEN TO PROVIDE SOME ENTERTAINMENT OR SOME PLACE FOR THE CHILDREN TO GO — TO KEEP THEM OFF THE STREETS.

Here Are The Facts

The Village Council is supposed to meet once a month. In two years this would be 24 meetings. THE PRESENT ADMINISTRATION IN THE TWO YEARS HAS HELD 60 COUNCIL MEETINGS. All open meetings to which THE PUBLIC ARE CORDIALLY INVITED.

A complete set of records has been kept SHOWING ALL BUSINESS TRANSACTED BY THE VILLAGE, including an up-to-date accounting system. These records are modern and would be a credit to a large business organization.

All Village debts have been paid. OUR CREDIT IS 100%.
Our bonds are selling a little above par.

Our system of books has already enabled us to retire a number of special assessments from numbers one to twenty-one... SOME OF THESE WERE TEN YEARS OLD.

This system has enabled us to save considerable interest by recalling bonds before their maturity on numbers 22 up to 44. THIS SAVING ALONE HAS MORE THAN PAID FOR ALL THE EXPENSES INCURRED.

THINK IT OVER.

Today we have plenty of water in the mains — NOT CON-VERSATION. Compare the cost of our pump house, land, and pumps with another North Shore village, about half———.
