NOTICE is hereby given to all persons interested that the City Council of the City of Highwood, Lake County, Illinois, have ordered the grading, draining, paving with Portland cement concrete and otherwise improving Sard Place and Summit Avenue from the east line of High Street east to the west line of Oak Avenue, Maple Avenue from the north edge of the present pavement on Michigan Avenue north to the southeasterly edge of the proposed pavement on Wrendale Avenue; Wrendale Avenue from the north edge of the herein proposed pavement on Sard Place and Summit Avenue northeast to the south line of Prairie Avenue; Oak Avenue from the north line of the present pavement on Michigan Avenue northerly and easterly to the west end of the herein proposed pavement on Burtis Ave. from southeast edge of the herein proposed pavement on Wrendale Avenue south and east to the west end of the existing pavement on Burtis Avenue, all in the City of Highwood, Lake County, Illinois. 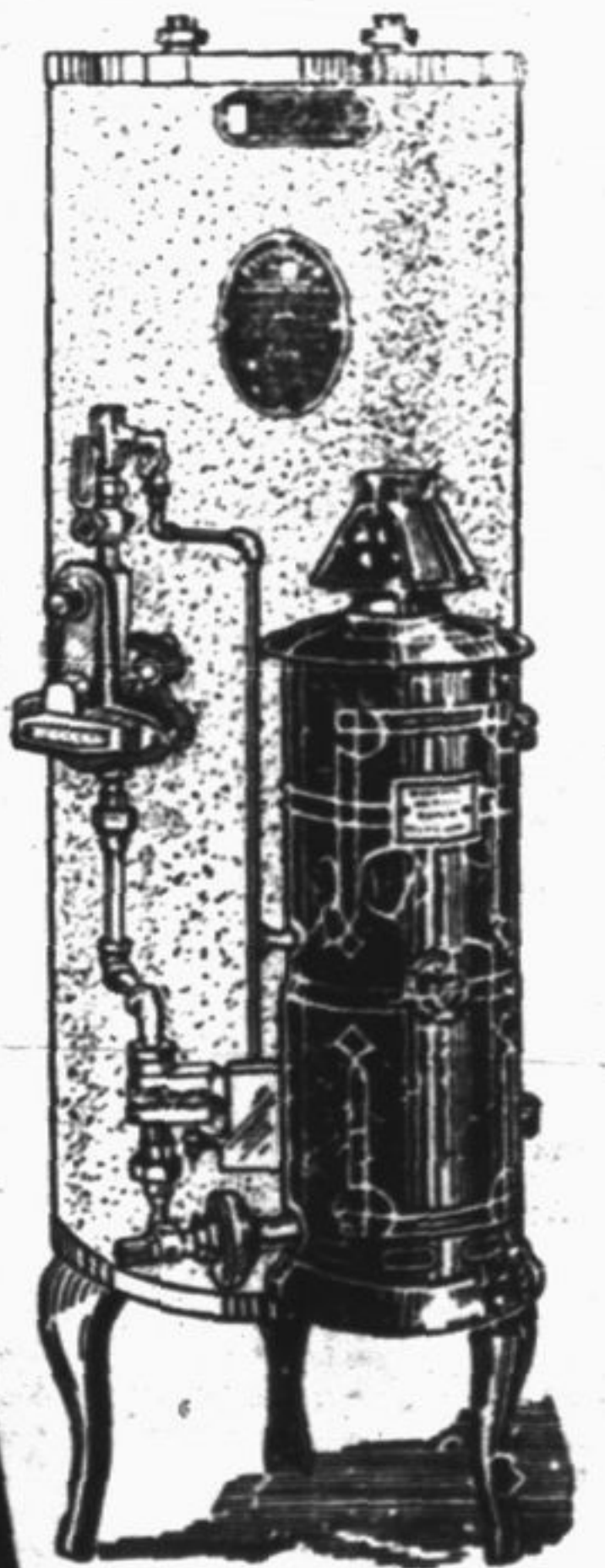
