

**CONTINUE HEARING  
IN FUND SHORTAGE**

**INDICTMENTS ATTACKED**

**State Asks Time to Prepare  
Answers in the Cases of  
Bracher Et Al; Be-  
fore Court Now**

The hearing on motions entered in the Circuit court Wednesday to quash indictments against those involved in the alleged conspiracy to defraud the county was continued by Judge Edward Shurtleff upon request of State's Attorney A. V. Smith, who asked time to prepare a defense of the state's indictments, which are being attacked.

**Attacks Indictments**

Attorney Ralph Dady, counsel for Roy Bracher, and Attorney McCarthy, counsel for Harold Martin, former cashier of the defunct Security bank, addressed the court, attacking the validity of the indictments, and stressing certain statements made by Judge Claire C. Edwards to the

jury which indicted the men. They claimed the statements were not impartial and tended to influence that body.

Attorneys of Clark C. Nye did not appear in court after their motion made in the morning session requesting a change of venue on the grounds that Judge Shurtleff had been involved in a case some years ago in which Nye was also involved. The motion was denied by Judge Shurtleff, but later stricken from the records, as the judge decided to consider the request.

The state admitted having been taken by surprise at the attack made upon the indictments by the attorneys for the defense and requested that time be given them to prepare a counter attack to preserve their indictments. No date was set for the hearing of the rest of the case but it will, in all probability, be held some time next week.

The quashing of the indictments would technically acquit the defendants in the case, but if such proves to be the case, they will be re-indicted, State's Attorney Smith stated after the Wednesday session, as the facts in the case still remain and cannot be dropped through technicalities in error in the present indictments.
